Vendors are responsible for supplying their own tents, tables, **5lb ABC fire extinguisher**, **Insurance cert**, and any additional equipment for their display. Setup for Shrimpfest may begin no earlier than the before the event at **2pm** to 7pm and must be completed by **10am Saturday**. Limited security will be available Friday night. Sebastian Blvd **will be closed** as of 8am Saturday morning. **No one will be allowed to park and unload from closed roads or inside the park**.



Each vendor space measures 10' x 10' and all display materials must fit within that area.
