Standard Terms and Conditions for Drilling Investigation Services

- 1. The scope of work, including equipment and materials, are based on information provided by the Client in the Drilling Services Request Form ('the Services') and in subsequent communications and should be clearly defined. The work will be charged based upon actual time and expenses incurred, per the quoted rates.
- 2. Hire of a qualified utility locater/clearance of any potential conflicts with underground utilities is the sole responsibility of the Client. Valley Wide will only drill and/or core at locations clearly marked or indicated by the Client.
- 3. Valley Wide will assume no liability for any losses or damages resulting from the provided Services; including (but not limited to) damage to underground utilities/services, damage to structures, encountered or generated site contamination, quality of obtained samples, encountered subsurface conditions, accuracy or content of subsurface logs (if provided), and any findings of investigations.
- 4. The Client will notify Valley Wide of any potential health and safety issues prior to initiation of the Services.
- 5. The Client will reimburse Valley Wide (cost of replacement or repair, plus markup) for down hole drilling equipment that is lost or damaged as a direct result of the provided Services.
- 6. Valley Wide will assume no liability for pollution of any kind encountered or generated at the site and no liability for cross contamination
- 7. Except as otherwise provided in the Services quote, all monetary amounts referred to in the provided quote are in CAD (Canadian Dollars), as per the provided rates/costs.
- 8. Payment by the Client is due within thirty (30) days from the date of the invoice. Any late payments may trigger a fee of 2.00% per month on the amount still owing.
- 9. In the event that the Services (as defined in this request form) are terminated by the Client prior to completion of the Services but where the Services have been partially performed, Valley Wide will be entitled to pro-rated payment of the Compensation to the date of termination provided that there has been no breach of contract on the part of Valley Wide.
- 10. Retainer fees may be required for certain projects, depending on upfront disbursements. The retainer amount will be provided in the Services quote.
- 11. By providing Valley Wide with authorization to proceed with the Services herein, including subsequent services and changes, the Client agrees to the above terms and conditions.
