We as a group of Journalist who work with and in some cases are affiliated with FCC Licensed radio stations (KPFF 97.7 FM and KPFV 98.1 FM) and bring forth the following complaint.

Attempts to obtain documents from the various County of NYE/Township of Pahrump offices has resulted in several of the following issues:

| Acting as if they don't understand what documents are being requested |

We ask that the Attorney General's office remind and instruct the County of NYE/Township of Pahrump that they are required to comply with Nevada Revised Statute 239 in its entirety not portions they choose to comply with. We intend to re-submit any failings that the County of NYE/Township of Pahrump has failed to comply with. If they then choose to fail in their duty to turn over those records in a timely manner and in compliance with the Laws, we will take further legal action.

We are exposing many layers and levels of actions that have been taken by persons elected, working for and working with the County of NYE/Township of Pahrump.
