Dear Phillip J. Pattee,

Thank you for your letter dated March 22, 2024, whereby you state that since a complaint has already been filed with the Judicial Review Board that the State Bar's File is closed. (Please see the attached letter).

I was not aware that the State Bar of Nevada turned over their authority to monitor members of the Bar Association once the person becomes a Judge. We were unable to find that anywhere on your website and policies of the Bar. If you could direct us to that information, it would be most helpful for our story.

Additionally, if the documents were reviewed you would also see that we are advising your office of issues with several other members of the State Bar of Nevada. We will specifically spell those issues out now.

Previous District Attorney Robert Becket, Bar number 3383 participated in an organization named Fifth Judicial District Adult Drug Court which was a 501c3. See printout from the Nevada Secretary of State website (Exhibit 1). He is listed as the Director. This organization was from the time period of August 2006 through 2012 was taking monies that were supposed to be deposited to the County of NYE. The monies were for the fees and fines paid into the Drug Court. This organization additionally used the 5th Judicial Courts address as their own most likely in an attempt to make themselves look legitimate. You can review the statements made by the independent auditing firm as to what they found (Exhibit 2). It gets even more complicated as this person was the District Attorney for the County of NYE during this period and was the person who brought charges against Defendants and argued the cases before the Court. The court in which Judge Robert Lane Nevada Bar number 4663 presided. Judge Lane was listed on this 501c3 as the President. Interesting that appears to be more than a casual conflict of interest. It's Criminal conduct.

Your own website states that following:

Our Goals are...

To govern the legal profession in the State of Nevada, subject to the approval of the Supreme Court;

To aid in the advance of the science of jurisprudence and in the improvement of the administration of justice;

To promote reform in the law and in judicial procedure;

To uphold and elevate the standard of honor, integrity, and courtesy in the legal profession;

To encourage higher and better education for membership in the profession;

To promote a spirit of cordiality and true friendship among members of the Bar; and

To manage the business of the State Bar in a prudent manner.

Then you have Judge Kimberly Wanker, Bar number 3838 who knew that this information was found. She ordered the audit prior to taking over the Drug Court Calendar. What was her Judicial Responsibility as it pertains to her duty to notify Law Enforcement?

According to the Judicial Conduct Rules for the State of Nevada it states the following:

Rule 2.15. Responding to Judicial and Lawyer Misconduct.

(A) A judge having knowledge that another judge has committed a violation of this Code that raises a substantial question regarding the judge's honesty, trustworthiness, or fitness as a judge in other respects shall inform the appropriate authority.

(B) A judge having knowledge that a lawyer has committed a violation of the Nevada Rules of Professional Conduct that raises a substantial question regarding the lawyer's honesty, trustworthiness, or fitness as a lawyer in other respects shall inform the appropriate authority.

(C) A judge who receives information indicating a substantial likelihood that another judge has committed a violation of this Code shall take appropriate action.

(D) A judge who receives information indicating a substantial likelihood that a lawyer has committed a violation of the Nevada Rules of Professional Conduct shall take appropriate action.

This would mean notification was to be made to the County of NYE District Attorney, State Bar of Nevada, The Nevada Judicial Review Board and most importantly the Nevada Attorney General should have occurred. We suspect none of the required reporting took place. We intend to find out by requesting documents from various agencies to validate our claim. We have good information that Judge Wanker did not comply with any of her Judiciary and State required ethics responsibilities.

To continue with the coverup of literally a theft of monies which belong to County of NYE, (the people) the then subsequent and currently serving District Attorney Brian Kunzi Bar number 2173 threatened anyone who inquired what he was going to do as far as this matter went. He then performed the most amazing job of covering this up and brought no charges. Nor did he report this matter as was his responsibility. Now the question is, why did he not do his job? We intend to find out who knew what and when.

The NYE County Controller Susan Paprocki additionally failed to report the facts to the Department of Energy and the facts surrounding the situation and made it sound like..."It's a mistake and we fixed it." (see Exhibit 3) The situation here is that members of the State Bar of Nevada have now actively covered up and failed to report serious crimes which is a direct failure of their duties.

To further complicate this story was the actual actions these players put to stop every single person who listened to an FCC licensed Radio Station who was broadcasting this information. This member of the media received insider information about what the Judge had done. The information was provided by several County of Nye County Commissioner Members who were frustrated that no action was taken against the players in this matter. The players in this matter went on to further violate a plethora of Constitutional and Civil Rights just to cover for Judge Robert Lane, District Attorney Robert Beckett and the Clerk Tammi Odegard. This information and documentation are forthcoming specifically of what was done to punish this disclosure in the past.

Now we further bring to your attention the criminal background request for Anthony Greco. Attached you will find directly from the Nevada Department of Public Safety letter which states, "Pursuant to NRS. 179A.100, the search failed to disclose a matching criminal history record based on information received on the background check". So now we have to look at what type of Kangaroo Court system are all the players involved with. They appear to have consistently and continuously violated the rights of the people before their system they created. Yes, we have more cases with other persons who had similar acts perpetrated against them.


So basically, we found the proof. Here it is.

We recommend you take a much more detailed look at what was provided to your office. We suggest that a lot of people in various agencies of Law Enforcement and Regulatory Bodies take a very close look. Everything and everyone who was dragged before the court while they were in charge and were perpetrating this fraud...may have had their rights violated.

A State of Nevada Judge, The County of Nye District Attorney, The County of Nye Subsequent District Attorney, and the County of Nye Clerk working for the Court created their own little non-profit. (Possible RICO) The monies of each person who appeared before the court during that time period were paid to whom? The non-profit. How many people were offered diversion so that they can contribute to the payments that ultimately were stolen? Did the people pay the Court or were things like credit card payments going over the internet paid to a non-profit? That brings up a lot of banking and wire fraud issues.

I hope after carefully considering what we have provided and the direct explanation of what was provided to you now twice, a closer and more serious review is done and your organization, in keeping with your own ethics rules, reconsider your position.
