

# 'List of possible offenses

## Description of actions:

On March 27, 2023, Anthony Greco filed a lawsuit against Marcelina Gonzalez due to a breach of contract. The case was subsequently assigned to Judge Robert Lane.

In addition to the filing there was a request to proceed in Forma Pauperis. This request has yet to be ruled on.

Anthony Greco the Plaintiff had Marcelina Gonzalez Defendant served on April 2, 2023. She was presented with a Summons and the Complaint. A copy of which is attached as Exhibits 1 and 2. Both these documents were provided to the court on April 10<sup>th</sup> 2023. While we have a stamped copy of the Affidavit of Service, we failed to have a copy for stamping pertaining to the Summons however we have attached the document as it was prepared and provided to the Defendant.

Defendant Marcelina Gonzalez failed to respond to the complaint. On May 17, 2023, the Plaintiff Anthony Greco filed under Nevada Revised Civil Procedure 55 as required for the Clerk of the Court to enter a default judgment. Anthony Greco attempted to file this default with the court. At that time the Counter Court Clerk by the name of Sarah Westfall notified Anthony Greco that she was instructed to not file stamp any documents presented by Anthony Greco by Judge Robert Lane. Additionally the Clerk of the Court Mark Kampf also advised Anthony Greco at that time he also has been instructed by Judge Robert Lane to take no action on this case.

You will see on Exhibit 3 that while there is no file stamp the Clerk date stamped the back of the first page in order to protect herself that indeed Anthony Greco attempted to file the appropriate document requesting a Default Judgement. The clerk of the court is not permitted to refuse documentation presented to the court. However, it is obvious that was done due to a direct order by Judge Robert Lane.

No actions were taken with this case until May 24, 2023, whereby Judge Robert Lane recused himself from the case. Attached as Exhibit 4.

Anthony Greco went to the Mark Kampf the County Clerk/Court Clerk the next day and inquired as to when the case would be re-assigned. Sarah Westfall inquired with Judge Kimberly Wanker to place the case on her calendar. She was notified that the judge would also be recusing herself

No action was then taken on this case. There was never a reassignment nor was there any actions as required.

On September 25, 2023, Anthony Greco notified the Clerk of the Court why this matter was not resolved and that due to Judge Robert Lanes recusal he needed to take his required action to enter the required default. A new request for Default Judgement was made to the Clerk of the Court, Mark Kampf.

This case was then assigned to Judge Kimberly Wanker after she had already verbally informed the clerk that she was recusing herself.

On the 16<sup>th</sup> of January 2024 there was a hearing before Judge Kimberly Wanker. During that proceedings she stated the following:

She read the complete file

The summons and proof of service were missing

Anthony Greco sat down, note the defendant never showed up.

Anthony Greco approached the bench and asked for the case to be reopened about 20 minutes later and stated clearly that the summons and proof of service should be in the file and that Judge Robert Lane had held this file for months and now documents are missing.

Judge Wanker again looked at the file and stated oh, here is the proof of service yet I still do not see the summons.

The Judge further stated that she is not treating Anthony Greco any differently than anyone else as well as the fact that he can view the case file anytime starting tomorrow it will be available at the Court Counter Clerks office.

On Thursday January 18, 2024, Anthony Greco went to the Counter Clerks office to view the file. He was informed that the file was not there, and the Judges clerk must still have it. Anthony Greco went to the Bailiff for Judge Wanker, and he was informed that the file was not with the Judge nor clerk.

Now the situation is that the file is missing. Any notes and the failure to follow the proper procedures of the court are in fact missing.

The documents attached are as complete that the Complainant can construct as it is obvious a mishandling has taken place.

To understand why this has happened you can reference a previous experience Anthony Greco has had with Judge Robert Lane. You may also want to reference the already filed complaint with the Judicial Review board Case #2023-158 as the person who was disclosing the facts was in fact Anthony Greco. This shows an ongoing pattern by Judge Robert Lane.

More complaints and other cases that Judge Robert Lane and Judge Kimberly Wanker has summarily dismissed whereby Anthony Greco was the Plaintiff will be forthcoming.

It is recommended that this matter be examined carefully, and parties are held accountable for their actions. As it stands it is basically impossible for Anthony Greco to recover damages against the Defendant in this case. So now who is responsible for his loss?
