

Possible Violations

Nevada code of Judicial Conduct

Rule 3.4 Judge continued to serve on the Las Vegas City Council all the while she was appointed as Justice of the Peace for the Township of Pahrump

Rule 3.12 continued to receive payment as council member for Las Vegas City while sitting as the Justice of the Peace for the Township of Pahrump

NRS 4.010

1. A person may not be a candidate for or be eligible to the office of justice of the peace unless the person is a qualified elector and has never been removed or retired from any judicial office by the Commission on Judicial Discipline. For the purposes of this subsection, a person is eligible to be a candidate for the office of justice of the peace if a decision to remove or retire the person from a judicial office is pending appeal before the Supreme Court or has been overturned by the Supreme Court.

While Fiore may have met the residency step of the Judiciary requirement in order to register to vote the person must already be a resident for at least 30 days to establish residency in the County of NYE. This is a requirement to be a qualified elector.

The County has continued to state residency was established and somehow because they appointed vs. had an election that somehow nothing else is a requirement. It is obvious that Fiore was not a member of the electorate and thus not eligible for the appointment.

The question now is how this gets remedied. What happens to all the decisions, both civil and criminal. It is apparent that the appointment was not legitimate and appears to also involve serious violation of the Nevada Statutes.

How can anyone have any reliability or respect for the Judiciary when items such as this keep appearing.
