On March 13, 2017, Anthony Greco was incarcerated due to actions by Judge Lane because he would not pay restitution. This restitution was never determined valid nor of an amount determination due to the failure to ever hold a hearing as it pertains to the conviction.

On December 28, 2017, Anthony Greco's legal filings with the Nevada State Supreme Court ruled that the incarceration of Anthony Greco was unlawful. The ruling suspended the sentence handed down by Judge Robert Lane.

Anthony Greco notified the CO of High Desert State Prison that his incarceration had been overturned. The Warden would not order the immediate release of Anthony Greco due to Judge Robert Lane having been told by the State of Nevada that his incarceration was not legal and the sentence had indeed been suspended. To remedy removal of Greco from High Desert Greco was moved the beginning of February 2018 to Three Legs Conservation Camp and now was under a different leadership as his incarceration was involved.

After a few days of his relocation to Three Legs Greco notified the CO that his incarceration had been overturned and showed him proof by the Nevada Supreme Court ruling. The CO called the Warden while Greco was present and updated him of the facts that Greco should have been released.

The CO once he hung up the phone while talking with the Warden he informed Greco of the following:

"Mr. Greco everyone in the State of Nevada knows who you are. We are trying to get you released however the Judge Robert Lane is fighting this release."

Anthony Greco was finally released from Three Legs about 3 weeks after his initial relocation there.

It was determined that Greco should be released to Parole and Probation as this progressed, however what actually occurred was that Judge Robert Lane ordered Greco to be incarcerated within NYE County Detention Center and that Greco has a prior Parole violation within the County of NYE. No such violation existed as Greco has no prior criminal history and was not ever incarcerated from any prior convictions.

Greco was then incarcerated at NYE County Detention Center until March 8, 20218. He spent a total of 359 days completely and utterly illegal. At no time did Judge Robert Lane have the legal authority to impose this incarceration per the Nevada Supreme Court ruling, and when notified of the illegal incarceration Judge Lane continued the illegal detention in violation of the ruling.

On March 8, 2018, there was a hearing about the incarceration in Judge Lanes Courtroom. During this hearing the State of Nevada AG office sent a representative names Attorney Ortiz was asked by Judge Robert Lane what do you want to do with Greco, Ortiz told Lane that Greco was his problem and we don't want anything to do with this guy or this case. Then Judge Lane looked at Gentry from Parole and Probation and asked him what you want to do, whereby his response was "I don't even know why we are hear as our department has nothing to do with this case". Then Lane tells Greco that he needs him to sign some release documents. Greco informed Lane that he was not going to sign any such document nor release Lane from anything. Then Lane stated that if you do not sign the release I am going to send you back to "Fish Tank" which referred to High Desert Facility. Greco responded that you illegally did this once you may as well do it again. At that point Lane became visibly and verbally stunned and obviously nervous due to the illegality of the incarceration to begin with. After hesitation Lane stated that if your

Lawyer Printy agrees to OR (Own Recognizance) I will release you today. Greco stated to his Attorney as long as I am not required to sign any documents releasing liabilities we can agree to this today.

Lane then stated okay OR yet Greco must report to Parole and Probation as part of the release. Greco was approached by Agent Gentry from Parole and Probation and was told to come see him in a few days, go get something to eat as Greco during this illegal process went from a weight of 200lbs to 158lbs.

Greco was on Parole for about a year after his release and at the conclusion he had not gotten into any trouble however Lane declared his release to be Dishonorable further violating Greco's rights.

Greco has paid over three (3 years) of costs to Probation all of which is illegal as the actual sentencing requiring him to pay restitution was deemed improper by the Nevada State Supreme Court.

Additionally Judge Robert Lane is and currently continues to be in contempt of the Nevada Supreme Court as the evidentiary hearing that they order has not occurred.

The amount of Both Federal and State Statues and Constitutionally protected right that have been violated against Anthony Greco is flabbergasting.

The information that this has happened is known by many within the Government of County of NYE.

CONCLUSION

Rights have been violated not just for Anthony Greco but for all that would have heard the information he was exposing as it pertains to Judge Robert Lane, DA Bob Beckett and Clerk Tammi Odegard and further coverup by the subsequent DA Brian Kunzi and the involvement in stealing from the County of NYE and the State of Nevada Drug Court Monies from 2006 thru 2013. At the time Anthony Greco was a member of the Media and worked with a FCC licensed radio station. This whole vendetta perpetrated stemmed from their actions to keep the truth from coming out about the theft.

It is important that this information is made public, that all parties who contributed and participated are held accountable and that appropriate actions are taken to clear Greco as well as compensate him for the ordeal he was required to endure.

More complaints and other information will be forthcoming after its release to the public.
