TERMS AND CONDITIONS

LIFE MARKET is brought to you by **Namaskar To You, LLC** also known as **Namaste Life (Events)**. The event will take place at **South Florida Hindu Temple** located at **13010 Griffin Rd, Southwest Ranches, FL 33330** on **Saturday, November 16th 2024**, from **10:00am to 3:00pm**.

This is a **FREE** event. Visitors are encouraged to register for the event for free through eventbrite so that we can keep track of the number of attendees.

This event is aimed at attracting attendees from the ayurveda/yoga/vedic community, vegan community, other special wellness communities, and beyond. This is a direct to consumer market that enables vendors to reach a demographic of conscious consumers. It is important that vendors come adequately staffed, stocked, and prepared to serve crowds.

While we can never guarantee an exact number of attendees to expect, we will remain transparent and communicate ticket registration numbers with vendors in the weeks leading up to the market in order to plan accordingly.

GENERAL INFORMATION

Event Details:

- This event is **STRICTLY VEGAN** - everything served and sold at the market must be 100% vegan and free from animal products / byproducts.
- Vendor registrations are on a **FIRST COME, FIRST SERVE BASIS**. Once vendor spaces are full, sign ups will be closed.
- **VENDOR SPACES ARE LIMITED FOR THIS EVENT** - we strongly encourage applying early to secure a spot.
- **Vendors will be assigned very specific LOAD IN & LOAD OUT times** for before and after the market.
 - To avoid traffic backups, blocking the road, and violating safety precautions, vendors are obligated to strictly comply and follow the Load In & Load Out Rules & Time Schedules.
- Vendors must begin break-down at 3:00pm when the event closes, and need to be off the park property by 6:00pm. Vendors are prohibited from packing up early and must remain intact until the event ends at 3:00pm.
- Attendance estimates will be communicated with vendors via email correspondence up until 48 hours prior to the event. Although the organizer will make every attempt to promote the event, attendance is not guaranteed.
- Vendor assignments are chosen by management based on the order in which vendors sign up and depending on how many of each category have already signed up.
- Vendors cannot request specific locations at the event. (Extra space is not always guaranteed.)
- **Any concerns or specific needs regarding your placement can be communicated to management via email.**
- Vendor load-in and load-out information, as well as the site plan, will be sent via email prior to the event.
- **All further communications will be sent to accepted vendors via email - it is critical to check your inbox for event information and updates.**

Venue Details:

- Vendors will be located on the east side of the premises.
- Parking is available at the venue and vendors can load at the front but will park at the back to allow for visitors to park up front. Please plan accordingly.
- Set up: 8:00am-9:45am. Breakdown: 3pm-6pm. Set up must be complete by 9:45am for inspection and check-in.
- There is no electricity.
- Damaging the grass in any way is prohibited! The grass in your tent must be protected and left in pristine condition after the event ends. Even when transporting your things to your tent, you must be conscious of not tearing up the grass.
- You CANNOT use stakes or grounding poles of any kind in the grass. Puncturing the grass is PROHIBITED - Water jugs, water weights, and sandbags are the only options allowed to weigh down your tent.

- Recycling is strongly encouraged.
- SALES: Vendors are permitted to make sales within their vendor space. It is the vendor's sole responsibility to obtain the appropriate licenses or permits as required by law, collect and remit sales taxes, and take care of any other legal business requirements. Sales are the sole responsibility of the vendor.

VENDOR COSTS

Vendor Fee: \$50

For Profit Vendors:

- Merch/Goods/Services Vendors include companies selling apparel, candles, soaps, body care, services, etc.
- ALL vendors **must** bring their own 10x10 tent. (Tents CANNOT be larger than 10x10).
- Vendors are required to bring their own additional materials, including tables, chairs, marketing materials, signage, etc.
- Vendors will have an assigned 10x10 space.
- Vendors who need an additional 10x10 vendor space are required to communicate with LIFE MARKET management upon submitting the Vendor Application. Additional fees may apply.

Non-Profit Vendors: (please reach out to us at events.namastelife@gmail.com)

- Non-profit vendors must be prepared to show their 501c3 upon submission of the Vendor Application.
- Non-profit vendors must bring their own tent and materials.
- Non-profit vendor spaces are extremely limited and there's a possibility that your application will be waitlisted.

Vendor Cost Breakdown:

- The Vendor Fee includes:
 - Social media advertising tailored to each individual vendor (on Facebook, Instagram, our website, and email newsletter).
 - Vendor waste management and recycling

Vendor Payments:

- LIFE MARKET management will follow up with vendors via **EMAIL** upon submission of the Vendor Application with approval or denial, and the exact amount due.
- If approved, vendors will be given 72 hours to submit their payment.
- Payments must be sent via Zelle or Venmo with specific instructions.

***Failure to submit your payment by the date and time given in the Vendor Confirmation email will result in the termination of this agreement.**

****Vendor spaces will NOT be held and are ONLY confirmed upon submission of payment and the signed Vendor Contract.**

Vendor payments are NON-REFUNDABLE.

LIMITATIONS

- This event is **strictly vegan and not garlic/onion friendly**, so the sale of anything containing animal products such as meat, dairy, eggs, honey, gelatin, casein, leather, feathers, etc. is **STRICTLY PROHIBITED**. The sale of artificially flavored and artificially dyed candies is prohibited unless certified vegan.
- The event date is subject to change or cancellation at any time (see **RESTRICTIONS**), in which case vendor fees may be used for the rescheduled event.
- While exact attendance isn't guaranteed, it is the sole responsibility of the vendor to be adequately stocked with enough staff to accommodate the event size.

LIMITATIONS (CONT.)

- Vendors must abide by the rules and arrive within the load-in time window to set up. (Exact times and the site map will be specified as the event gets closer.)
- Vendors are permitted to make sales within their tent space between the hours of 10:00am-3:00pm only.
- **VENDORS ARE PROHIBITED FROM SELLING ALCOHOL.**
- Packing up before the 3:00pm break-down time is **strictly prohibited** and **attempts to do so will result in a \$100.00 fine.**
- Vendors that sell out before 3:00pm are welcome to put up a "SOLD OUT" sign and enjoy the market until closing.
- Vendors must be packed up and off the premises by 6:00pm. Vendors will be given very specific load-out instructions.
- Damaging the grass in any way is prohibited. Vendors must not dump grease or oil in the grass and ground, and must not puncture the grass in any way. **Doing so will result in a \$500 fine.**
- Coal fired cooking devices are prohibited.
- Bathrooms are available.
- Trash must be disposed of in the bins provided at the venue. **Leaving trash behind will result in a \$500 fine.**

- Leaving grease of any kind behind is STRICTLY prohibited. You must safely dispose of grease OFF of the Park's property.
- It is the vendor's sole responsibility to obtain the appropriate licenses or permits as required by law, collect and remit sales taxes, and obtain any other legal business requirements. Sales are the sole responsibility of the vendor.
- Vendors are responsible for providing images to be used for social media promotion on LIFE MARKET accounts.
- Vendors grant LIFE MARKET/Namaste Life under Namaskar To You, LLC. an unlimited license to use any photos or videos taken at the event at no additional cost.
- **VIOLATION OF STATE AND LOCAL ORDINANCES AND/OR LIFE MARKET POLICIES MAY RESULT IN THE EXPULSION OF THE VENDOR FROM THE VENUE OR ANY STATE OR LOCAL APPLICABLE PENALTIES.**

VENDOR AGREEMENT

Liability:

Neither the event managers, event producers, (LIFE MARKET under Namaskar To You, LLC.), nor the venue (SOUTH FLORIDA HINDU TEMPLE/ CITY OF SW RANCHES located at 13010 Griffin Rd, Southwest Ranches, FL 33330), the event staff/employees, nor security, officers, agents, directors, or representatives are liable for any damages or loss that may occur to the vendor or to the vendor's employees or property from any cause whatsoever, included but not limited to weather, negligence, attendees, etc.

The vendor, on signing this contract, agrees to indemnify and hold forever harmless the aforementioned for any and all liability and expense for personal injury, accident, claims, suits, or property damage from fire, death, theft, destructive causes, or loss arising out of, in, at, or in connection with the vendor's display and participation.

Insurance and liability are the full and sole responsibility of the vendor. It's recommended, but not mandatory, that vendors provide a copy of insurance with "Namaskar To You, LLC." (16520 South Post Rd, Suite 302, Weston, FL 33331), listed as Additionally Insured. This documentation must be provided through email by November 15, 2024 at 11:59pm EST.

Choosing to forego insurance means that you are accepting full responsibility for any losses, damages, accidents, and/or potential legal action against you or your business that may occur. If needed, you can obtain temporary, one-day event insurance from websites such as theeventhelper.com

Restrictions:

Namaskar To You, LLC. management reserves the right to restrict vendors that become objectionable because of noise, method of operation, materials, or for any other reason, and to prohibit or evict any vendor that, in opinion of the management, may detract from the general character of LIFE MARKET/Namaste Life under Namaskar To You, LLC, South Florida Hindu Temple, and the City of SW Ranches as a whole. This restriction includes persons, things,

conduct, printed matter, not abiding by protocols, failure to present insurance, or anything that the management determines objectionable in character. In the event of such restriction or eviction, event management is not liable for any refunds or other vendor expenses. Event will take place rain or shine. Should devastating weather or natural disaster occur, the event will be rescheduled.

Event is subject to change dates or be postponed at any time. All vendors must be adequately staffed and must remain intact until the official closing hour of 3:00pm. Early dismantling is disruptive to the event and poses safety and security hazards, therefore, vendors must not pack, tear down, or remove any portion of their vendor setup prior to the official closing at 3:00pm. Early breakdown is strictly prohibited and will result in a \$100 fine.

RECAP OF POLICY

Signature accepting our NO REFUND policy and agreeing to the LIFE MARKET Vendor Agreement in its entirety. All payments are NONREFUNDABLE. This is a 100% VEGAN (as well as no garlic/no onion) event. Only vegan products can be sold, sampled, or promoted. All tents must be weighted with blocks or barrels of water. Tents may not be staked anywhere. **A fine of \$500.00 per tent will be assessed for any tents which are staked or for any grass ruined by oil or other cause.** We do this to avoid staking any waterlines or electrical. Please make sure the weights are heavy enough to withstand strong winds that could occur. No refunds for vendor tables/booths. No cancellation.

I understand vendor spaces are not transferable unless otherwise agreed to in writing by Market Producer. Vendor booth and sponsorships will not be refundable. To the maximum extent permitted by law, in no event shall Namaskar To You (Market Producers), Namaskar To You owners, or any of their subsidiaries, sponsors, affiliates, directors, shareholders, officers, employees, volunteers and agents be liable for any direct, incidental, indirect, consequential, special, punitive or exemplary damages of any kind, including without limited (i) lost revenues or profits (ii) loss of business or loss of data (iii) loss or damages to any personal property including computer, mobile phone or other device that is in any way related to our Event, even if Market Producers and its subsidiaries, sponsors or affiliates have been advised of the possibility of such damages; or (iv) for any claim, loss or injury based on errors, omissions, interruptions or other inaccuracies in our program or websites, including without limitation, as a result of breach of any warranty or other terms of the Terms, the use or inability to use our official website or services, the software, unauthorized access to or alteration or your transmissions of data, statements or conduct of any third party in the website. Some states do not allow the exclusion or limitation of liability of consequential or incidental damages, so the above exclusions may not apply to all users; in such state liability is limited to the fullest extent permitted by law. I understand this is a "Force Majeure Event" which means any cause(s) which render(s) Producers wholly or partly unable to produce this Event, which are neither reasonably within the control of such Producers nor the result of the fault or negligence of such Producers, and which occur despite all reasonable attempts to avoid, mitigate or remedy. Such causes shall include

acts of God, war, riots, civil insurrections, cyclones, hurricanes, floods, fires, explosions, earthquakes, lightning, storms, chemical contamination, epidemics or plagues, acts or campaigns of terrorism or sabotage, blockades, embargoes, accidents or interruptions to transportation, trade restrictions, acts of any Governmental Authority, strikes and other labor difficulties, and other events or circumstances beyond the reasonable control of such Producers. No refunds will be given. All sales are final.
