#### 7. Additional Support Needs (ASN)

While we do not offer specialised ASN-specific lessons, we are committed to inclusivity and provide swimming opportunities for children with Additional Support Needs. Our staff are informed of individual requirements through communication with parents and carers to ensure a supportive environment.

## 8. Data Sharing

We do not sell or rent your personal information to third parties. We may share your information with:

- Service Providers: Trusted partners who assist in delivering our services.
- Legal Obligations: Authorities or organisations when required by law, such as for health and safety or safeguarding purposes.

#### 9. Data Security

We implement appropriate technical and organisational measures to protect your personal data against unauthorised access, loss, or destruction. This includes secure servers, encryption, and access controls.
