### **Arizona Knights of Columbus Leadership Change**

#### **State Deputy Resignation and Restructuring of State Officers**

PHOENIX – July 24, 2019, in a letter to the 17,000 members of the Knights of Columbus in Arizona, Tom Kalisz, the State Deputy for the Arizona State Council of the Knights tendered his resignation from his position in order to attend to personal matters. In the letter, Past State Deputy Kalisz thanked the membership for their trust in him and for their service to the State Council, their brother knights, and the people of Arizona. He closed his letter by asking his directors and chairmen to continue to support the State Council as they work to accomplish their goals for the new fraternal year.

“I would ask the State Council Officers to strongly encourage each of you to continue to fulfill your roles in support of our Mission this fraternal year. I ask that you continue to support the order with the same zeal and love that you have shown this past year,” said Kalisz.

In a special meeting of the State Officers held the same day, the resignation of Kalisz was accepted. A letter to the membership was issued the following day stating, “The State Council is sad to learn of the resignation of Tom Kalisz from the office of State Deputy for Arizona. We thank him for his many years of service to the Arizona Knights of Columbus, from District Deputy through State Deputy.”

The letter also stated that, after reviewing several alternatives, the remaining State Officers decided that, in accordance with the bylaws and rules of the Knights of Columbus, they would fill the vacancy and other offices in the following manner:

State Deputy – Mario Vassallo  
State Secretary – Luigi Baratta  
State Treasurer – Tom Kato  
State Advocate – Kevin McCarthy

The vacancy of State Warden was filled by State Programs Director Larry Powers until the May 2020 State Convention and election of officers. Sean Halpain will remain in the role of Immediate Past State Deputy. The officers assumed their roles and responsibilities immediately.

The new State Deputy, Mario Vassallo, of Vail, Arizona, has served the Knights in various leadership roles throughout his membership including District Deputy and State Council offices to State Secretary, the post he was serving in most recently.
