1. General Information

2. Ticket Purchase and Confirmation

- 2.1. All tickets are subject to availability and are only considered confirmed once full payment has been received.
- 2.2. Once payment is completed, a booking confirmation will be sent to the email address provided during the booking process.
- 2.3. A valid ID may be required for entry to the event.

3. Payment Terms

3.1. Full payment is required when booking unless otherwise stated.

3.2. Accepted payment methods include

- Bank Transfer

3.3. All payments are final. No changes or adjustments can be made once the payment has been processed.
