- As lead negotiator for the Trade Related Aspects of Intellectual Property Rights (TRIPS) Council at the WTO and at the World Intellectual Property Organization (WIPO), we successfully presented the Intellectual Property Legislation Review and Nicaragua acceded to the Paris Patent Agreement, the Madrid Trademark Agreement and the UPOV 1978 convention.
- Negotiated the accession processes to the World Trade Organization of the People's Republic of China, Chinese Taipei, Saudi Arabia, and the Russian Federation. Obtaining sizeable exclusive quotas for Nicaragua's main exports.
- Chaired the Working Party on Rules of the General Agreement for Trade in Services in the period 2003-2004, becoming the first Nicaraguan delegate to preside over a subsidiary body of the WTO and the youngest delegate to date elected as Chairperson of any subsidiary body in this organization.
- Participated in the preparatory processes of 4 Sessions of the WTO Ministerial Conference (Seattle, Doha, Cancun, Hong Kong) and as a delegate and national coordinator in two of them (Doha and Cancun).
- Drafted and tabled with other representatives, the WTO Declarations of TRIPS and Public Health in 2001. Similarly, I was part of the drafting teams that tabled the proposal for a Tourism Satellite Account in 2001 and the proposals that created both the G20 and G33 informal groups.
- Coordinate the ITU Latin America and the Caribbean Group in the period 2004 to 2005. Nicaragua, at that time, held the Vice Presidency of the World Summit on Information Society (WSIS); in that context I was appointed Deputy Head of Delegation of Nicaragua. The Latin America and Caribbean Regional Group chose me as Rapporteur of the Regional Summits in Rio de Janeiro and Quito where we drafted the Regional Plan of Action and the Regional Declaration for the development of Information and Communications Technologies (ICTs) for the Region in compliance with the Millennium Development Goals (MDGs)
