SUMMARY: To address the unprofessional behavior of Dr. Perry-Rose and her misrepresentation of Adventist Health. Copies will be provided to appropriate legal and professional association conducts regarding her violations of her oath and patient rights.

COMMENTS: to quote the declaration of Independence, "when in the course of human events it becomes necessary to break the ties which bond us..." (U.S, 1776) It has become necessary to break my relationship with Dr. Perry-Rose, "in order to form a more perfect union..." (U.S, 1776) Her disrespect of myself, AMCP, and her ~~profession~~ profession are astounding. My disbelief in GOD stems directly from such behaviors as people like Dr. Perry-Rose. Honesty and truth are clearly secondary to health and welfare followed by the thirst of greed.

Should we examine the patients bill of rights, we can explore together the massive breakdown of the patient/doctor privilege, beginning with a patients right to, "be recognized and respected for personal and cultural diversity in the provision of care and treatment, (AMCP, 2010) As we can see from the previous complaints neither staff or attending physician take this seriously or it would be part of my treatment and ~~to~~ its disregard by fellow patients would not be ignored.

Next, I was promised by Dr. Perry-Rose a Comprehensive treatment plan outlining behaviors desired and a release date to be reviewed on Thursday, September 20, 2012, in lieu of one being drafted during my first (7) Seven days at this institution. On the due date, I was only told I would not be going home and she had no treatment as agreed. This was not the first time I have been lied to in direct violation of hospital policy, State Law, her oath, and my rights as a patient.

Next, my right to representation by an attorney and my right to habeas Corpus (PMAC, 2010)

I would have never entered into any agreement had I known the falsehoods and misrepresentations this institution and Dr. Perry-Rose would attempt.

Since my admission I was promised a room on a more appropriate ward, specifically 4300. To date, no go. Back on 9/15/2012 under Camera I revoked my 14 day diversion before Cody Kuschel and informed staff. That revocation pre-dates this document by at least (5) five working days. (Circuit Court, 2012)

With regards to initiating the complaint that preserves the therapeutic aspects (PMAC, 2010) until today 9/20/2012 when the Director of Psy. Services came to discuss this matter, I was ignored. I had to use the following to initiate the resolution process and reserve my right to allow the public to view and speak with those involved in the interest of preserving public trust in the Profession.

my right to institute a complaint was further hindered by false promises regarding my treatment, my stay, my status at the facility, and my growth.

I believe that my right to the maintenance and Confidentiality was violated with respect to written and verbal communications when a patient, Cheryl, began asking me "why I liked Condoqs and not pussie"? There were other incidents over several days leading up to Cheryl's outing of me and my ex-partners relationship resulting in a final report to nurse on duty Amy. However not before another guest announced that, "he had a real problem with that". How many violations of the Patients Bill of Rights can we find right there?

The Saga Continues as we see that I am held Captive in this hostile environment, which, according to the patient bill of rights, "a safe environment and to be free of physical or verbal abuse and sexual harassment." (PMAC, 2010) Incidents reported promptly.

With direct responsibility to Dr. Perry-Rose, she has, aside from the aforementioned, failed grievously to protect me from unusual or potentially hazardous treatment procedures by lying to me making any decision I make based on her "advice" and not evidence, "Potentially harmful". (AMCP, 2012) over

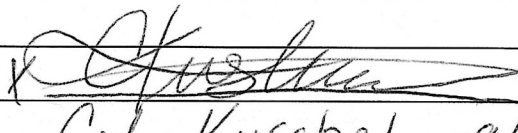

SUMMARY: After being released by Court order request to Adventist Doctors to continue Prescript meds until I can get an appointment and medical coverage DENIED!

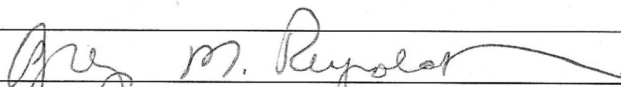
