

Dear Special Agent Green:

I'd like thank you and Special Agent Bass for stopping by earlier today at 1315 or so. After speaking with, unretained and unnecessary, legal counsel I have been advised that if you are investigating my civil rights complaints against:

Portland State University, Portland Adventist Medical Center, the Portland Police Bureau, the Oregon Department of Justice, or you are planning on supplying me with the requested search warrants and police reports for your previous visit in September 2012, or aiding with the other Oregon Department of Justice issues,

then I will be at our scheduled meeting tomorrow, 7/24 @ 0900 documentation in hand.

I have several people currently working on whether or not they can help me with my civil rights issues. If you have any information which may help them, I have signed and returned, releases of information for, Earl Blumenauer; case 00504061-74463, Senator W. Cowan, Senator M. Udall, as well a letter from Senator R. Wyden promising my day in court over all this. A date which has yet to come. The only "war" which exists is the one for my rights, my day in court, and against further discrimination, whether it be because you are gay, or disabled, or black, etc., or any combination thereof.

Otherwise, per the US Supreme courts ruling, I am asserting my constitutional rights at this time, all of them, including the 5th. I have no additional statement(s) of any kind, and will be unable to attend our meeting, nor will I without proper legal counsel. As posted on my front door and also per court ruling(s), please don't drop by without a warrant.

Thank you for your visit, it was a pleasure to meet you both.

I have been fined and that is on my credit report, without due process of law, I have had my home searched and seized without due process of law, and I just wonder why does the law not apply to me? Why is it Glock is my only friend and nobody violates my rights when he at my side. Of course the last time the police were here harrassing me the admitted, "What PSU did was illegal." and they left, of course no police report copies for me regarding that incident either, but I have pictures! I just want my day in court even if you require me to walk into a school and open fire just to get people to discuss this incident with me. I have had enough of my rights being violated, I sucked Dennis Michael Pughs dick and swallowed 20 years ago to make the State of Oregon happy and now when we go to court everyone is going to know you knew this whole time. I cant even see a mental health counselor. The last time after being ordered by PSU to see one and suspended so I could, I got expelled for the treatment I did receive, that was confidential and PSU was not even on the release of information. I was expelled when I wasnt even a student. Sir I see that action as a threat, and I intend to retaliate with equal and greater power. This is war. I am looking forward to another of war with Portland State University. So whats is gonna be Mr. Senator, either way an arrest or not, this case will make it the press, lets go!!!! I've been waiting for you promise of day in court for over a year, but I have gotten are the "secret courts" that need to be exposed. This has gone on long enough and for 710 a month in SSI, I obviously cant afford legal, so if you cant do something about this, I will have no choice but to handle PSU myself.

As ordered by Jackie Balzer and PSU and has been universally accepted as law by each and every member of the US Senate, the office of the President of the United States, the PSU Board of Trustees, Jim Fransceoni, Commissioner Kaufry, Gregory Kafury, Governor John Kitzhaber, the Oregon Attorney Generals office, the Multnomah County Sheriff's office, the Circuit Courts of the State of Oregon cases 120970073, 140201438, the Social Security Administration, the US Department of Justice, the FBI, Disability Rights Oregon, Congressman Blumenauer case 00504061-74463, Oregon BAR TWJ1400136, as well on the approval of Kristen Snowden Multnomah County DA's office and Chrystal M. Dear Nancy Cozone and the Oregon Public Defenders Office:

Now that you are a witness to the fact the the laws of this nation and the Constitution do no apply to me, you must understand that in lieu of due process Portland State University has determined I am "permenently and irreversibly" expelled from all rights and obligations under all state and federal laws. This has been confirmed along with my right to shoot those in the face with a Glock 17 9mm for violating my rights and denial of due process. 

DOMANIC THOMAS, address 1825 SW Broadway, Portland OR 97201, phone number 503 725 5341, was interviewed at his place of employment, Portland State University, by Special Agent Jake Green and Task Force Officer Cora Childers. After being advised of the identity of the interviewing Agent and the nature of the interview, DOMANIC THOMAS provided the following information:

DOMANIC THOMAS, here after referred to as THOMAS, is employed as by Portland State University (PSU) as the Assistant Dean of Student Life and Director of Conduct and Community Standards, Dean of Student Life - Student Affairs. In this job THOMAS is one of the people responsible for determining when a student has breached the code of conduct at PSU. A few years ago THOMAS was involved in expelling GREG REYNOLDS (REYNOLDS) from PSU for threatening emails.

Since his expulsion from PSU REYNOLDS has continually sent angry, and violent emails to people at PSU describing his perception of his rights being violated, his desire to have the situation rectified, and violent consequences if he does not see satisfaction. The emails have been filtered and forwarded to Campus Safety for review, generally without THOMAS opening them.

Most of the interaction between REYNOLDS and THOMAS has been through phone conversations. THOMAS did give a presentation to a class a few years ago that REYNOLDS was in. The presentation consisted of a welcome to PSU and generally what to expect. In the presentation THOMAS made mention of background checks being necessary for some jobs. THOMAS thinks it was REYNOLDS who asked questions about the background check. THOMAS described the person as concerned about needing a background check, as if he wouldn't pass. THOMAS is aware of REYNOLDS having a felony on his records and thinks this might have been why REYNOLDS was concerned about a background check.

Sometime in 2014, the Office of Student Life began to have internal discussions about some of the threats from disgruntled students towards personnel at the Student Life Office. at the forefront of the discussions were the emails from REYNOLDS. The emails had become somewhat regular, and

consistently described violence as a solution. As a result of the threats, the office of Student life had panic buttons installed in the offices. In the event someone comes to the office and intends violence, personnel can press the panic button and alert Campus Safety. The panic button instillation cost around ten thousand dollars.

THOMAS knows what REYNOLDS looks like and has passed his photo around the office so the other people in the office can identify him if they see him on the campus. If THOMAS were to see REYNOLDS on campus he would immediately assume he is there to seek revenge through violence. The emails REYNOLDS sent THOMAS and the rest of PSU make THOMAS feel threatened, and in fear of harm.

MICHALE NATHAN MORRIS, hereafter referred to as MORRIS, has lived with GREG REYNOLDS (REYNOLDS) for approximately one and a half years. MORRIS and REYNOLDS are friends, and roommates. MORRIS has heard REYNOLDS talk about emails he has sent.

REYNOLDS sends emails talking about his expulsion from Portland State University, and other things going on in his life. Frequently the emails show REYNOLDS as upset, and possibly threatening. MORRIS is aware of the emails because sometimes REYNOLDS includes MORRIS on the distribution list of his emails. Sometimes REYNOLDS boasts about some e-mail he has recently sent. MORRIS has heard REYNOLDS say he sent an e-mail to somebody stating "I'm going to shoot you in the face with a gun". Often REYNOLDS rants about emails he has sent talking about his problems. MORRIS thinks the emails have a cathartic effect on REYNOLDS. MORRIS does not think REYNOLDS will harm anybody.

MORRIS stated REYNOLDS is looking forward to getting to court where he can question people regarding how they have wronged him.

MORRIS has heard of REYNOLDS talk about having a gun. MORRIS does not believe REYNOLDS has a gun. The two men cleaned out REYNOLDS' fathers home after his death. REYNOLDS would not even touch his fathers guns, in fear of getting in trouble for being a felon in possession of a weapon.

GREG MICHAEL REYNOLDS (REYNOLDS), date of birth (DOB) 08/17/1973, was interviewed at his residence of 35612 Southeast Macinnes Road, Corbett, Oregon, 97019 by writer and Secret Service Special Agent (SA) Ronald W. Brown. Federal Protective Service Inspector Douglas Rommes and two Multnomah County Sheriff's Office Deputies were present at REYNOLDS residence during this interview. SA Brown advised REYNOLDS of REYNOLD's Miranda rights, which REYNOLDS verbally acknowledged and waived. After being advised of the identities of the interviewing agents and the nature of the interview, REYNOLDS provided the following information:

REYNOLDS was convicted of a felony, Delivery of Controlled Substances to Minors, in approximately 1993. LARRY PARKER (PARKER) was REYNOLDS' defense attorney for this matter. REYNOLDS illegally acquired, and partially compensated PARKER with, food stamps. DENNIS MICHAEL PUGH was the Lane County Assistant District Attorney who had prosecuted REYNOLDS for this matter.

When REYNOLDS was asked why he was sending threatening communications online pertaining to opening fire on schools, REYNOLDS said that he would feel as if his punishment would fit the crime if he had opened fire on a school. Writer understood the crime and punishment REYNOLDS mentioned, as referring to REYNOLDS' aforementioned conviction and the resulting issues he has had to deal with since.

Writer showed REYNOLDS a copy of a form submitted online to the Social Security Administration on 09/11/2012. REYNOLDS explained that this form was an application for Social Security Adult Disability and confessed that he did write the threatening statements in this form and submit it online.

Writer also used writer's blackberry to show REYNOLDS a copy of an e-mail sent to Nancy Corzine on 07/12/2012. REYNOLDS immediately recognized the e-mail, said, "this is the one I got suspended from PSU for," and confessed that he did write the threatening statements in this e-mail and send it to Nancy Corzine, who was an employee of the Oregon Public Defender's Department. REYNOLDS also printed out a copy of this e-mail from his personal computer and provided this copy to writer.



CODY MICHAEL KUSCHEL, hereafter referred to as KUSCHEL, has been in a relationship with GREG REYNOLDS (REYNOLDS) for approximately three years. KUSCHEL has lived with REYNOLDS at his current address for approximately a year. REYNOLDS was expelled from Portland State University a few years ago, which has been an issue the whole time they have been together.

REYNOLDS was convicted of a felony approximately twenty years ago, and has been having a hard time finding a job ever since. He has not been able to find a good job, and his life has suffered as a result. REYNOLDS feels the difficulties in his life are a result of his rights being violated by potential employers, and government entities who continue to allow his felony to show up on his record. KUSCHEL stated REYNOLDS feels like everything is against him to move forward with his life. Years ago, out of frustration he wrote an e-mail to President Obama. The e-mail said "what do I have to do, walk into an elementary school and start shooting." referring to his plight in life and his multiple failed attempts at bringing attention to his unjust situation. As a result of this email he was expelled from PSU for violating the University policy regarding conduct. REYNOLDS sees this as an additional violation of his rights and he is upset about his expulsion. KUSCHEL stated REYNOLDS was getting some benefits from attending school. REYNOLDS was getting money for tuition, books, and some living expenses on top of his disability checks. Now he is no longer able to apply for these benefits and it has negativity affected his life and finances.

REYNOLDS told KUSCHEL he sends emails to get attention. When Law Enforcement comes to talk to him about the emails, he ignores them so they have to come back with a warrant to arrest him. He wants to be arrested so he can have his day in court. REYNOLDS believes going to court will give him the opportunity to question all the people he believes have violated his rights, exposing his plight and vindicating him.

A month or two ago, REYNOLDS told KUSCHEL about an e-mail he sent out that said "I'm going to shoot you with a Glock". KUSCHEL couldn't remember who the e-mail was to, but he remembered REYNOLDS telling him about some of the emails he sent. REYNOLDS would tell KUSCHEL about some of the more offensive statements he put in the e-mail like "you can lick my black hairy pussy". KUSCHEL was unwilling to repeat any other statements REYNOLDS relayed to him because they were offensive, and racist. KUSCHEL described the emails as generally aggressive, threatening and mean. KUSCHEL couldn't remember any other specific threats REYNOLDS put in his emails, but wouldn't be surprised if there were more.

KUSCHEL stated he has seen REYNOLDS' mentality change in the last month or so, to be more stressed and hectic. KUSCHEL state he is quicker to anger and is more frustrated than ever at his current situation. KUSCHEL stated REYNOLDS feels stressed because of their financial situation. REYNOLDS is behind on several bills, and feels no hope in getting back on his feet. REYNOLDS has not been able to find a job, and blames his felonious record. REYNOLDS' disability check is not enough to live on, and he doesn't feel like he has other options.

Cody Michael Kuschel, date of birth ~~11/20/83~~, (Telephone number ~~901/852/4812~~) was interviewed at a residence located at 41603 NE IRA Jones Road, Amboy, Washington 98601. After being advised of the identity of the interviewing Agents (TFO Dan Diamond and TFO Tony Bass) and the nature of the interview, Kuschel provided the following information:

Kuschel stated that he has been in an intimate relationship with Greg Reynolds for the last three years and that the two of them live together at Reynolds' residence located at 3516 SE Macinnes Road in Corbett, Oregon.

Kuschel stated that his mom lives at the mentioned Amboy, Washington address above and that he works on the property. Kuschel also stated that his mother, Connie Kuschel, is bi-polar and that he tries to help her out.

Kuschel stated that he believes Reynolds is not an insane person nor will he ever hurt/harm anyone. Kuschel stated that even though people may think Reynolds is a violent person, he is just letting people know how he feels regarding an incident that happened about 20 years ago in the Medford area and 2 years ago at Portland State University.

Kuschel stated he did not know much about the incident in the Medford area, but was told by Reynolds that an attorney named, Dennis Michael Pughs, had represented Reynolds for legal advice and was sexually assaulted by Pughs. Kuschel stated that Reynolds told him that Pughs had forced Reynolds to perform sexual acts against his will in order for Pughs to act as his attorney.

Kuschel did not want to go into detail about the type of sexual acts that Reynolds was forced to perform on Pughs.

Kuschel stated that the PSU incident had occurred about 2 years ago when Reynolds sent an e-mail from his PSU e-mail account to President Obama asking for help regarding the incident in Medford.

Kuschel stated that Reynolds was a current PSU student at the time when the e-mail was sent to President Obama. After the e-mail was sent Reynolds was informed by PSU that he had violated the school policy for sending the e-mail and was subsequently expelled. Kuschel stated he did not know what

the e-mail detailed. Kuschel stated he knew of another e-mail that was sent out by Reynolds to other important people (Gov. Kitzhaber, PSU, FBI, DHS, etc.) the e-mail mentioned that Reynolds' only friend was a GLOCK (firearm) and a question about when would Reynolds get his day in court. Kuschel also stated that he remembered the e-mail consisted of something about walking into a school with a firearm and shooting up the place, but did not read anything else. Kuschel stated he believed the e-mail was sent out because Reynolds has not been able to get the help or justice he needs regarding the Medford incident and why PSU expelled him from school.

Kuschel stated that Reynolds does not have any mental issues, but has been diagnosed with depression and is currently taking prescription medication for it. Kuschel stated that Reynolds had voluntarily gone to the Portland Adventist Hospital for a psychiatric evaluation about 1.5-2 years ago and was admitted to the hospital for a 2 week mental evaluation. Kuschel stated that he believes the police officers that were at the house that day forced Reynolds to sign a voluntarily admittance form for a mental evaluation and that was why Reynolds had to go to the hospital. Kuschel stated he did not remember which law enforcement agency the police officers were from.

Kuschel stated that he knew Reynolds had been trying to get police reports from the Portland Police Bureau, PSU and other law enforcement agencies, but no one will help him. Kuschel stated he has tried to get the reports on his own as well and no one has helped him out either. Kuschel stated that Reynolds had met with other law enforcement agencies in the past, but the encounter did not go very well. Kuschel stated that Reynolds had told him that he will only meet with the police if they have a search warrant and then Reynolds will speak to them. Kuschel stated he was not sure why Reynolds will only speak to the police if there is a search warrant at hand. Kuschel stated that Reynolds does not have any money for an attorney and that they live off of Reynolds' \$700.00 (Disability) and \$200.00 (Food Stamps).

Kuschel stated that their roommate, Mike Norris 65-70 years old, also lives with them, but wants Norris to leave the residence because he has not been paying rent.

Kuschel stated that Reynolds told him that there is a Glock in the house (mentioned address in Corbett) and that the firearm is locked in a key/combination lock box. Kuschel stated he has not ever seen the Glock in the house, but was told where it was kept. Kuschel also stated that Reynolds had told him there were no bullets for the gun.

Kuschel stated he had told the interviewing agents too much and that he was done talking.

This assessment should be closed and if further assistance is needed by the MCSO they will inform the Portland Division.
