



Associate Accoutrements Agreement

All Associates operating a place of residence or company-owned vehicle, including cars, motorcycles, motor scooters, planes, jet skis, and slingshot vehicles, agree to operate the vehicle according to the following guidelines. Failure to adhere to these guidelines may result in the revocation of a associate's privilege to operate company vehicles or termination under some circumstances.

As part of the company's commitment to ensuring the comfort and well-being of our associates, we provide certain perks and rules regarding places of residence and hotel accommodations. Associates are entitled to company-funded accommodations at designated hotels or residential facilities during business trips or assignments. These accommodations are selected to provide a comfortable and conducive environment for work-related activities. While residing in these accommodations, associates are expected to adhere to the following rules: maintain the cleanliness and condition of the property, respect the privacy and comfort of other guests or residents, and promptly report any damages or issues to the property management and company. Unauthorized guests or activities that may cause disturbances are prohibited. Additionally, associate must adhere to the check-in and check-out times and any other policies stipulated by the accommodation provider. These rules are in place to ensure a pleasant and professional living environment for all associates.

- Associate must maintain a proper and current driver's license for the type of company vehicle that they are operating and notify management immediately if they no longer have a valid license.
- Associate will notify the company of any citations received while operating a company vehicle.
- Associate must follow generally accepted safe driving practices and obey traffic regulations.
- Associate will ensure that all occupants of a company-owned vehicle are properly wearing safety belts while the vehicle is in motion.
- Associate is responsible for ensuring that the vehicle is properly maintained. This includes having the vehicle serviced at regular service intervals by a qualified mechanic.

- Associate authorizes the Company to obtain and review the Motor Vehicle Record of the Associate.
- The vehicle may not be used for non-business use in accordance with the conditions outlined in this agreement. The Associate agrees to operate the vehicle in such a manner that will not expose the company to excessive liability or risk.
- Company-owned vehicles are not to be used for family vacations.
- Associate is financially responsible for any parking or traffic violations while operating a company-owned vehicle.
- Associate must report all accidents within 12 hours of the occurrence to the Company.
- Associate will be responsible to pay any deductible in the event an accident is deemed avoidable.
- Associate will not make any modifications to any company-owned vehicles.
- Vehicles are not to be loaned to any other party not allowed to operate company vehicles.
- Company and Associate agree in the event the vehicle provided is a luxury vehicle.
- Towing of mobile homes, travel trailers, or any type of recreational or utility trailer is prohibited.
- Associate is responsible for parking vehicles in safe and legal areas off public ways.
- The use of alcohol and controlled substances prior to and during operation of any vehicle is prohibited.

This authorization may be terminated by the company at any time.

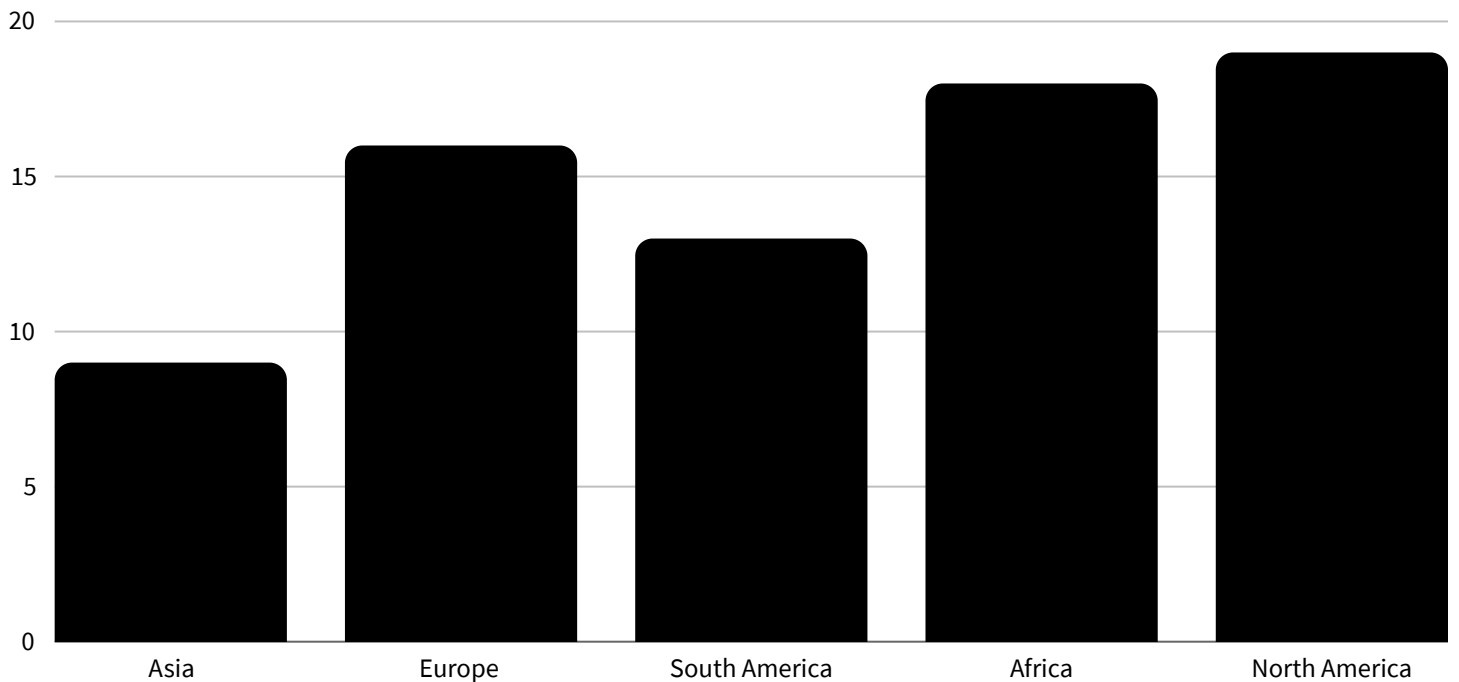
