Copy of Driver's License for each attendee. (**ALL** Expo participants will be prescreened in the National Sex Offender database. If you are a match, you will not be permitted to enter the YMCA). **Attach a copy of your driver's license to this form.**

Certificate of Insurance of General Liability for **ALL** vendors and sponsors is required to participate in events hosted by or in partnership with the YMCA . **Attach a copy of the certificate of insurance to this form.**

Products and services may **NOT** be sold within the YMCA program space.

NOTE: Failure to submit the information by the requested deadline may result in being denied participation.

YMCA of Florida's First Coast is a Child Safe Place. All participants will be prescreened in the National Sex Offender database. If you are a match, you will not be permitted to enter the YMCA. A driver's license is required to search for a possible match.
