Vezina, a Notary Public, in and for the Parish of Jefferson, State of Louisiana, personally came and appeared the person whose name is hereunto subscribed, of the full age of majority and a resident of the City of Gretna, who declared, in the presence of the undersigned competent witnesses, that, availing himself of the provisions of Louisiana Revised Statutes, 12:201-12:269, he does hereby organize a nonprofit corporation as defined in R.S. 12:201 (7) under and in accordance with these articles of incorporation.

ARTICLE I.

The name and title of this corporation shall be the BELLE MEADE CIVIC ASSOCIATION.

ARTICLE II.

This Corporation is organized on a non-stock and nonprofit basis to promote the social, cultural, educational, physical, environmental and public well-being of Belle Meade Subdivision residents and to engage in an lawful activity for which nonprofit corporations may be formed.

The Board of Directors shall have the power to make, amend and repeal by-laws to govern this corporation, provided they are in accordance with and do not conflict with these articles.

ARTICLE VI.

ARTICLE IX.

If this corporation be dissolved with finances in the treasury, a two-thirds vote of the membership present can determine the disposal of such funds.

ARTICLE X.

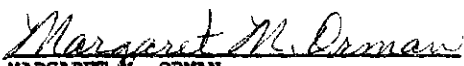
