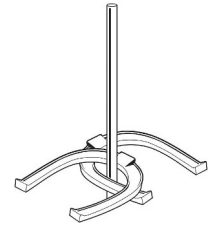

ILSHPA State Membership Meeting
Saturday August 30th 2025
Reported by Don Goers

Meeting called to order by President Dan Broeckling at 11:55 AM

Rolled call of officers and all are present.

Dan Broeckling President, Anna Thornquist 1st Vice President, Dan Freeman 2nd Vice President, Austin Bailey 3rd Vice President, Tara Kinsella Statistician, Deanna Marvin Junior Director, and Don Goers Secretary and Treasurer and Publicity Director.

Minutes of the 2024 state meeting were posted on the website and Eric Marvin motion to accept and Kenny Keifer 2nd. No amendments Passed .

Financial Report given by Don Goers. Beginning Balance 8/4/24 \$15,250.94 and Ending Balance 8/19/25 \$16,664.84. Motion Mike Wood to Accept and 2nd by Kenny Keifer Passed.

Financial Report for Junior account given by Deanna Marvin Beginning balance as of 9/1/24 \$11,258.17 and as of 8/28/25 \$11,595.35. Motion Mike Woods to accept 2nd by Kenny Keifer Passed.

Officer Reports: None

Committee Reports: Larry Thomason stepped down as By laws committee chair and Thanked him for serving and now Sam Mataya is chair with Sharyl Mataya and Harl Morgan on the committee.

Old Business: NONE

New Business:

Harl Morgan brought up to Amend article VIII Sec 3d to remove the wording "clubs cannot hold successive State Touraments". Harl mentioned that it takes away from choices for the location of state for a particular year and if there is no club to host state the previous year could not put in a bid as a result.

Voted on 47 yes 12 no Passed

Harl Morgan brought up to Amend Article 8 Sec 6 subsection 1 to say "Cadets/Juniors may receive monetary rewards at the state tournament or choose to keep it in the junior fund"

Discussion

Eric Marvin: The scholarship money can be used for anything for higher education, (books, supplies, trades classes and ect.

Larry Thomason: asked could juniors be dropped from ISHA if we paid.

Deanna Marvin: wants one way or the other.

Austin Bailey: If we pay the juniors then they need to pay to get in the tournament like adults do.

Kenny Keifer: Asked what would happen to the junior fund. Deanna mentions to put it back in a general account that is not spoken for.

Dan Broeckling: Wants something in writing from ISHA and a lawyer to protect us if we pay out money to a junior so at this time no votes and will be on old business. I need to do more research.

Harl Morgan brought up to Amend Article 3 Sec 4-1 to increase dues to \$50. The extra \$10 to go towards prize money for the state tournament.

Leo Bratland: Asked how much the extra \$2 person was this year, response was \$920 added

Kenny Keifer: If NHPA raises then how would the extra \$10 work

Larry Thomason: Against it because I don't think that will help to get people here anyhow.

Voted 26 yes 30 no 3 did not vote Failed

Harl Morgan Brought up to Add to Section 6 to Article XI to state "the state will assist with Cadet/Junior travel expenses for the world tournament up to \$300.

Eric Marvin: Why pay \$300 for 1 person to go to the world and we pay only \$200 for 4 people to go to team world. Also when you go to the world you do it as a vacation also.

Dan Broeckling: Asked if we pay are we liable if something happens during traveling.

Deanna Marvin and Sheryal Mayata asked to have it amended so that we pay the juniors entry fee.

Dan Broeckling mentioned that we would provide specific wording that states that the World fees would be paid at the current rate of the NHPA entry requirements.

Harl agrees to that.

Voted 35 yes and 24 no Passed

Harl Morgan brought up to add to Sec 4 to article IX that "a; sanctioned tournaments will allow video taping, recording or live streaming of all events and games" to help promote the game

Eric Marvin: think more about this and try to use you tube channel

Zack: how this would affect the rules of them and the etiquette of pitching

Dan Broeckling: would this come back to get the organization legally.

Jim Spidle Jr.: can we sign a waiver for each tournament

Anna Thornquist: asked what about spectators

Dan Broeckling: still wants some legal advice

Kenny Keifer motioned to table this idea til we get more information and Deanna Marvin 2nd it. It will go into old business.

Harl Morgan brought up a map showing the regions of the state so we know where the committee members are from. No discussion.

Voted 38 yes 17 no 4 did not vote Passed

Harl Morgan brought up to have a change of duties from first vice president to promotions/marketing director and scrapbooking to go to the publicity director.
