From the Statistician

We are having changes in the Natstats department. Starting in January, you will no longer be able to check on your stats thru Natstats. You must go to Eshoes for this. The way to do it is.

Click on Eshoes on the NHPA website. Go to the players area and type in your name. Select your correct name with the city you live in. Your information should come up with your average, your card information if it needs renewing, also an area that says Details. Click on it and it gives you all of your tournaments you have entered in. There will be a trophy in your 3 highest averages. This is how the NHPA will track your averages and tournaments.

With Eshoes you will no longer need your cards to verify. The tournament director should check to see if you had renewed your card BEFORE you pitch.

For all Tournament Directors:

Please make sure you update the new HS Master to your computer.

Also Please go to the You Tube.com site and look up Paul Stewart how to videos. He has set up videos on how to set up tournaments in Eshoes along with how to in HS Master. This is essential to all Directors to learn this. On Facebook, the National Horseshoes Pitching Association has a direct link to the site.

When you have entered your information and completed your tournament your file that you made up will automatically be updated to Eshoes and won't have to wait on Natstats. I will check your tournaments, verify that cards are renewed, new members entered etc.

Message from the 2nd Vice President Lee Watkins

Hello Everyone. Hope you are all safe & healthy. I am writing to clear up any confusion about the procedure for medical exemption. As you know the NHPA allows any 40ft pitcher to pitch from 30ft with an exemption. The process can be timely. For a member to apply they must first fill out the required form and send it to the ILSHPA 2nd VP (currently me). He/She (2nd VP) then sends a form to the doctor to fill out. The doctor usually returns it to the officer (2nd VP) in a timely manner, but I've seen It take weeks. After form is received a panel discusses the request and a decision is made. The member, secretary and NHPA are notified by letter. Pitchers are not allowed to pitch from short distance until approved. This procedure must be followed. If you have any questions feel free to call me. Thank you for your cooperation.
