The new Buzz.....ZELLE, See if your bank has ZELLE

Don Goers has been working on the Third way to pay your card renewal, court reporter, state entry and doubles tournament entry online. He will be getting an article on the procedures here in the court reporter. How it works is you can transfer the money from your bank account to the ILSHPA bank account. Your Bank must have the ZELLE support program. When you do you, put a description of what you are wanting to do, Say make a card renewal, for Kenny Kiefer, transfer the money the state sec/treasurer and Austin gets a notification that it's done, and we make the necessary paperwork to complete the transaction. You can also pay for the entire family without adding the extra \$1.60 extra per transaction. You make one payment. This sounds confusing now but Don will set up procedures, the how to's later in our article. I'm just giving you an overview of the new Buzz. Thank you, Don, for all the hard work you do!
