All games has only 4 participants the class will play a double round robin. All games will be 40 or 50 cancellation depending on class size. Any games that are tied after the shoe limit is reached will continue play "down & back" until tie is broken. First place in each class will first be determined by wins and losses, if there is a tie with wins and losses the next criteria will be head to head competition. If still tied then the highest ringer percentage will determine the winner.

The cost for entering is as follows; Men's entry fee is \$40 per entry; \$11 scorekeeping for a 12 player class. Men's 30' entry fee is \$40 per entry; \$9 score keeping for a 10 player class. Women's entry fee is \$40 per entry, \$9 score keeping for a 10 player class. Junior Class no charge. Non-Sanctioned Double Tournament Entry fee is \$20.

Check the appropriate boxes and mail entry form and fee <u>All entries must be postmarked NO LATER</u> THAN JULY 15th, 2024 All pitchers must have an NHPA membership card. After the schedule is done it will be posted on the ILSHPA web site and in the August Court Reporter.

Non-Sanctioned Doubles Tournament is a **walking mixed (men and women) doubles format**. The 16 person classes will be sorted in a descending order based on ringer %. The #1 person will be paired with the person in that class, #2 person will be paired with the 15th person in that class, etc.
