

- No score 4 shoes	call	No score
- 1 shoe in count	call	1 point
- 2 shoes in count	call	2 points
- 1 ringer	call	1 ringer, 3 points
-1 ringer & 1 shoe in count	call	1 ringer, 4 points
- 2 ringers	call	2 ringers, 6 point
- 1 ringer each, no shoe in count	call	2 dead, no score
- 1 ringer each, 1 shoe in count	call	2 dead, 1 point
- 3 ringers	call	2 dead, 3 points
- 4 ringers	call	4 dead
