For those who turned 65 in 2023, you can change your status to elders. When renewing let me know that you want to move up and I can change the status when you renew. If you change from 40' to 30' your tournaments from 40' will be removed, you will need to qualify again to be placed in a division % for your tournament director 100 shoes is enough for that. Then your tournaments begin at 30' and 3 for state and 4 for world tournaments are needed to qualify for these venues.

I understand that Tara and Don are keeping a top 5 total scores for player of the year on the ILSHPA.org website for everyone's viewing. Look on who is in the running so far! Thanks Tara and Don for those updates each month.
