Hello Everyone. Hope you are all safe & healthy. I am writing to clear up any confusion about the procedure for medical exemption. As you know the NHPA allows any 40ft pitcher to pitch from 30ft with an exemption. The process can be timely. For a member to apply they must first fill out the required form and send it to the ILSHPA 2nd VP (currently me). He/She (2nd VP) then sends a form to the doctor to fill out. The doctor usually returns it to the officer (2nd VP) in a timely manner, but I've seen It take weeks. After form is received a panel discusses the request and a decision is made. The member, secretary and NHPA are notified by letter. Pitchers are not allowed to pitch from short distance until approved. This procedure must be followed.
