Name:

WhitePaws RunMitts Maryland Flag Mitten Contest (“Contest”)

Purpose:

As a Baltimore brand, WhitePaws RunMitts is looking to celebrate the creativity of Marylanders by collaborating with a local artist on a special edition release of RunMitts. Artists will create a vector-based motif inspired by the iconic Maryland flag. The winning artist will see their design turned into a repeat print for our special edition RunMitts and will also receive a cash prize of \$500.

NO PURCHASE NECESSARY. Entrants to the Contest must be 18 years or older and be living in the state of Maryland at the time of entry. Sponsor reserves the right to verify all eligibility requirements. By entering the Contest, each Entrant represents and warrants that they meet all eligibility requirements and acknowledges that failure to meet all eligibility requirements will disqualify Entrant from the Contest. Contest is subject to all applicable federal, state, and local laws and regulations.

How to Enter

Download the entry form available at www.runmitts.com/contest and fill out all required fields. Email your completed entry form and vector artwork to runmittscontest@gmail.com. Entries are complete when both the entry form and artwork have been received by Sponsor. Entrants will receive confirmation of receipt via email.

All entries must be received by 11:00 AM Eastern Standard Time on September 15, 2021.

Artwork requirements:

- Must be a vector graphic
- Submit your artwork in JPG or PDF format. If chosen as the Winner, artwork must be made available to Sponsor as an editable vector file such as .ai
- Must utilize the following CMYK color codes to represent the Maryland Flag colors:
 - Black: 0_0_0_100
 - Red: 0_100_63_31
 - Gold: 0_29_100_1
 - White: 0_0_0_0
- Name your files in the following format:

 - Artwork: YourFullName_YourArtworkTitle_2021 example:

 - Artwork may be submitted as a repeat or as a standalone motif.

The Winner's artwork will be turned into a repeat print for textiles, so it is recommended that you consider how your design will look tiled. Dimensions of the RunMitts are approximately 9.5" L x 4.5" W for size medium. Sponsor reserves the right to modify the scale of the design to best suit the project.

Each Entrant may only submit one entry

Submission Guidelines

All artwork submitted by the Entrant must be original and created solely by the Entrant. All entries must not contain material that violates or infringes another's rights, including, but not limited to, privacy, publicity, or intellectual property rights, or that constitutes copyright infringement. Sponsor reserves the right, in its sole discretion, to disqualify any entry it deems to be offensive, inappropriate, derogatory, indecent, obscene, hateful, tortuous, defamatory, slanderous, libelous, or that is not in compliance with the terms of these Terms & Conditions. Voting will start on September 16th and run through September 19th at 11:59 pm Eastern Standard Time. 1 Like = 1 Vote and the entry with the most Likes at the cutoff time will be the Winner.

The Winner will be notified via email on September 20th. The Winner will be required to email an editable vector file, such as .ai file, to runmittscontest@gmail.com by 11:59 pm Eastern Standard Time on September 21st, 2021.

Prize

The Winner will receive a \$500 cash prize and may have their design turned into a repeat print for special edition RunMitts.

All prize details are at the sole discretion of Sponsor. No substitutions or transfers of the prize are permitted by the Winner.
