Board Meeting Minutes, January 14, 2026

Call to order - Mr. Brabrook called the online meeting to order at 8:04PM.

Review / Approval of meeting minutes: Mr. Van Dijk moved to approve the 9 September 2025 minutes as amended with a second from Ms. Neal. The motion was approved unanimously. Ms. Neal moved to approve the 11 November 2025 minutes with a second from Mr. Van Dijk. Both motions were approved unanimously. The draft annual meeting minutes were reviewed in preparation for approval at the annual meeting on 10 November 2026.

II. Old Business:

- The draft Collections Policy Resolution formalizing the existing procedures for addressing delinquent accounts was reviewed. Mr. Tolbert moved it be approved as written. This was seconded by Ms. Neal. This was accepted by unanimous consent. The resolution will be signed by Mr. Brabrook and Mr. Thorp. The document will then be filed and posted on the website.

III. New Business:

- Board member terms of office were confirmed clarifying Mr. Van Dijk's term will complete the term started by Mr. Taylor.
- The current liability insurance policy coverage of \$250,000 was discussed and questioned. A motion by Mr. Van Dijk was to retain this level of coverage and renew the policy. A second was provided by Mr. Tolbert. This passed unanimously.
- Establishing a Fairfax County Community Parking District for the Crestbrook HOA was discussed. The effort to establish this for the HOA is significant. The intent is to provide members more information regarding this topic in the Spring newsletter.
- A Fairfax County Unified Trash initiative is underway, considering the creation of a Unitary Sanitary District. The HOA is to complete a survey and has the opportunity to attend an online meeting on 3 Feb 2026. The board's response is mixed. They see key advantages and disadvantages with this initiative. Getting HOA members to respond or provide a preference will be a challenge. This will be another Spring Newsletter topic.
