 City via email. You can email me (Sam Chambers) any questions. Please include the project
 title in the subject line.
- All questions and responses will be included in the Addendum.
- Prospective bidders will walk the site at the conclusion of this presentation.
- Contract Documents are available to purchase in portable document form (PDF) on a flash
 drive at the City Clerk's office. The purchase cost of the flash drive is \$10 if picked up or \$20 if
 mailed. It is the contractor's responsibility to ensure they are on the City's Plan Holder's List
 and they obtain any addenda or clarifications that are issued by the City on the City's website
 prior to submitting a bid.

C. CONTRACT PROVISIONS

- The Contractor shall possess a valid Class A Contractors License, or any combination of applicable Class C Contractors Licenses, as necessary to perform the work, at the time of contract award, in accordance with provisions of Chapter 9, Division III of the California Business and Professions Code.
- If a contractor is planning to bid and complete the work with their own forces, they are
 informed to note the requirements on the BID pages for verifiable information that must be
 included for journey level workers.
- Review the specifications carefully, paying close attention to the Instructions to Bidders, Bid Pages, and Bidder's Questionnaire.
- Please complete all bid pages thoroughly. Please submit all bid pages.

- Complete the Bidder's Questionnaire fully; do not simply attach separate company resume pages.
- Bidder's Bond is for 10% of bid.
- Payment and Performance Bonds are to be 100% of bid.
- Contract requires all bonds to be underwritten by a corporate surety with an A.M. Best Rating
 of A: VII or better.
- Contract requires \$5 million liability insurance.
- The Special Provisions of this contract are arranged in a sequence that follows the Green Book-Standards for Public Works Construction, and in some cases supplement or amend it.
- The time for performance for this contract is 90 working days, inclusive of a 15 day
 mobilization period. It is noted that the City owns 90 working days from the start of
 construction regardless of the fact that a bidder may calculate his bid on less days.
 Highlights of contract timing milestones:
 - Bid Opening is Tuesday December 2nd at 11:00 AM in Lakewood City Hall. Address
 contained in spec book; room to be determined by the City Clerk; bidders are
 welcome to attend this public bid opening.
 - Contract award is expected tentatively Tuesday, December 9th.
 - Contract Docs must be submitted on or before Tuesday, December 23rd
 - Contract Notice To Proceed will be issued on execution of contract documents.
 - The Notice allows the awardee contractor to begin the submittal phase, but it doesn't allow on-site work without an approved construction schedule.
 - Construction on site shall begin after an approved construction schedule.
 - Contract will be awarded to the lowest <u>responsible</u> bidder, which may not necessarily be the lowest monetary bidder.

D. Description of Improvements

The work generally consists of demolition, grading, concrete foundations, play equipment installation, rubberized surfacing and installation, and miscellaneous related improvements required by the contract documents. Contractor to remove existing play equipment, footings and sand. Contractor to furnish, assemble, and install play equipment, shades and resilient surfacing. The engineer's estimate is \$478,436.91.
