The following changes, additions, deletions or corrections shall become a part of the Contract Documents, for the project named above and all other conditions shall remain the same. The bidders shall be responsible for transmitting this information to all affected subcontractors and suppliers prior to the closing of bids.

1. LIST OF PREQUALIFIED GENERAL CONTRACTORS AND MECHANICAL, ELECTRICAL, PLUMBING (MEP) SUBCONTRACTORS

The contractors for this project have been vetted through the prequalification process under California Code. All General Contractors (“B” license”) and Mechanical Electrical Plumbing (“MEP”) Subcontractors (Licenses “C-7” and “C-10”) must be on the attached prequalification list from PQBids provided within this addendum.

For this project, “C-7” and “C-10” subcontractors must still be listed on the Designation of Subcontractors Form as each trade has been prequalified by PQBids.

Once again, General Contractors may NOT self-perform MEP trades unless they are also listed with “C-7” and “C-10” licenses on the “**Lic Class**” column on the attached list. Even though General Contractors may hold subcontractor trade license(s), they must be approved on the PQBid’s prequalification list included in this addendum in order to perform the work. It is the General Contractors’ responsibility to check the list carefully to ensure which license(s) they are prequalified for or when selecting subcontractors.

Per the instructions contained within this bid, all subcontractors must be identified on the provided Designation of Subcontractors Form if the value of services are equal to or greater than one half of one percent of the base bid per California Code. If any bidder fails to list the required Subcontractors or fails to use a prequalified MEP Subcontractor, they may be deemed non-responsive, leading to disqualification.
