Rental Application Requirements and Qualifying Criteria



It is Illegal to Discriminate Against Any Person Because of Race, Color, Religion, Sex, Handicap, Familial Status, or National Origin.

1. All adult applicants must complete and sign an New Start Home Rentals Rental Application.
 2. Rental application must be complete.
 - Include two most recent pay receipts for each applicant for employment and income verification.
 - If you are self-employed, 2-6 months complete bank statements are required.
 - If you are employed by the military, a current copy of your LES is required.
 3. Minimal household income requirement:
 - Three (3) times the monthly rental rate on gross income.
 - Two and one-half (2.5) times the monthly rental rate on net income.
 4. Application processing fee:
 - \$50.00 per adult on the Rental Application.
 - The application fee is non-refundable.
 - All adults that will be living in the rental property must be on the Rental Application.
 - Application processing fee includes all background checks, credit checks, criminal background checks, Social Security Fraud checks, records for Judgments & collections, evictions, contacting current and past landlords, employers, etc.
 5. Fico scores must be at or above 600.*
 6. No eviction history.
 7. No court ordered Judgments or collection accounts.*
 8. No Felony convictions.
 9. Good "Debt-To-Income" ratio.*
 - Monthly debt payments must be less than 35% of monthly gross income.
 10. Pets: Each rental property will have a unique "Pet Policy".
 - Review ads and ask agent for detailed information on pet restrictions.
 - Written authorization is required for approval of ALL pets on Premises.
 - Certain breeds of dogs categorized as "Dangerous Dogs" are not allowed.
 - An additional non-refundable "Pet Fee" is required for all pets.
- *Variances may be requested and reviewed on an individual basis regarding FICO scores and credit issues.
