The actual number of reported kidnappings every year are in the many thousands, the unreported incidents are significantly more with in excess of 80% of all global kidnappings unreported and managed discreetly.

Fortunately, for foreign nationals travelling or working overseas, they equate to just a small percentage of the total incidents. The numbers are obviously very fluid each year as trends and security stability shifts by region. However there are still a considerable number of foreign nationals globally impacted by kidnap and extortion each year.

Business travellers, Humanitarian workers, Maritime crews, Journalists, Mining, Oil and Gas and Expedition adventurers are all regular victims, but tourists or travellers of any type are also targets.

Some incidents make the news, most do not and for good reason.

Reputable Private Kidnap Consultants assist in many cases, and often non disclosure agreements prevent such reporting.

In Australia and overseas families, victims and employers have criticised their Governments authorities response and assistance in helping its citizens during kidnappings. However it is a complex and convoluted matter requiring much diligence.

Whilst some incidents have a political or other motivation, most are about money or information, and with the right professional response and process, can be effectively resolved to secure a safe repatriation.

Sadly though, all too often this is not the case.

# Kidnap and ransom, the risks, reality and response

- The vast majority of kidnappings are never reported
- Most incidents do not make the news
- Foreign nationals travelling are just a small percentage of victims
- Governments, Police, Military in most countries are often bound by procedure, foreign policy, political and legal nuances
- Such constraints can not be accommodated to achieve a fast, safe repatriation





#### **The Response Reality**

- There are many types of kidnap incidents
- They are complex dangerous crimes
- Rescue is usually dangerous
- Kidnapping requires the most diligent nuanced response with one focus
- No competing agendas or political constraints

Rescue is often the most dangerous solution and is best avoided unless there are no other options. Be aware this may be out of your control or a standby option requiring much influence to mitigate.

Incident types vary across regions, but what is clear, is that without the right professional response and process the risks of tragedy are significant.

In many regions kidnap victims are killed before or after a ransom is paid, the reasons are variable, but are better avoided with a professional response process.

In kidnap for ransom incidents the victim is simply a commodity and the perpetrators want maximum profit for that commodity, with minimum risk.

#### The Response Reality

The Police, Military, legal institutions, Intelligence agencies and Foreign Affairs Departments of the country of kidnapping and country of victims residence or citizenship, could all have a role, dependent upon those countries involved.

Accordingly they are then all encapsulated in any incident management. Furthermore employers, insurance providers and families are all possible stakeholders, creating a complex response with competing agendas.

The parameters and complications with this are that each has a differing approach, set of rules, and agenda.

The police may wish to arrest the criminals to make a region safer. Intelligence may need them for information on bigger criminal groups. Foreign Affairs may wish to maintain country trade and diplomatic relations at all cost, and the Military may wish to rescue.

It's complicated, but the employer or families influence and control is often minimal, unless they engage their own professional support.

Kidnappings are a vile appalling crime. The victim is normally completely vulnerable when their world is turned into violent chaos and life threatening uncertainty. Soon after for the family and employer it's a long roller coaster of awful psychological and catastrophic turmoil.

So what is a professional response and process.

A reputable Private Kidnap Consultancy will be a multi disciplined team that abides by it's legal obligations and works discreetly and efficiently to repatriate the victims.

We generally work for the family direct, the employer or insurance underwriters.

This is obviously good for those successfully repatriated, but can make the process more risky, especially in regions where they can quickly dispose of one victim and gain another. This is normally in regions with poor governance and security where 'express' style kidnappings or fast cash and rapid turnover is common.
