Joan Hughes seconded. Motion passed unanimously.

<u>COMMITTEE REPORTS</u>. Pat Esno volunteered to serve on the Architectural Review Committee. Brian Campbell made a motion to appoint Pat Esno to the ARC. Dan Truetlein seconded. Motion passed unanimously.
