<u>PROOF OF NOTICE OF MEETING:</u> In accordance with by-laws and statutory requirements, the notice for this meeting was posted on the clubhouse bulletin board. The sign notifying residents of this meeting was placed on the clubhouse lawn the day prior to the meeting.

READING AND DISPOSAL OF UNAPPROVED MINUTES: Brian Campbell moved to accept the meeting minutes and Shirley St. Clair seconded the motion. The motion passed.

<u>TREASURERS REPORT:</u> Current information on expenditures, income and assets was shared by Marty Clifton, Board Treasurer. Donna Burns-Russell moved to accept the report and Brian Campbell seconded the motion. The motion passed.

UNFINISHED BUSINESS:

COMMITTEE REPORTS: COMMUNICATION COMMITTEE

<u>RULE ADDITIONS</u>: Brian Campbell reviewed the process used to determine designated smoking and alcohol use areas on the common grounds. This was approved at the October meeting. This resulted in the petition lacking the required number of signatures, The petition was deemed invalid.
