### GSB Financial Report

One of the Advisory Actions passed at the 73<sup>rd</sup> General Service Conference came from a recommendation from the Conference Committee on Finance and it was that "The Trustees' Finance and Budgetary Committee develop additional ways to report quarterly the fiscal performance of the AAWS, GSB and GV Boards throughout the year to the members of the General Service Conference for the purposes of transparency and assisting in the reporting to the A.A. Fellowship." In response to this Advisory Action, Kevin Prior,

Class A (Non-Alcoholic) Trustee and Treasurer of the GSB, has provided us with an unaudited Quarterly Financial report for Q4 2023. This report contains financial statements for the 3 Boards, as well as some narrative explanations to help members of the Fellowship understand what the reports are showing. There is also a consolidated budget presentation that includes financial highlights for the past several years to better explain how we arrived at our current financial position.
