COVID-19 Health Implications:

- Currently does not apply: I agree to ensure that my child adheres to UK government laws regarding COVID-19, including those relating to self isolation and social distancing.
- If my child has, or I think my child might have COVID-19, we will not attend class until s/he is fully recovered and at least 10 days after the first symptom occurred and at least 7 days after all symptoms have gone.
- If someone my child lives with has COVID-19 or if s/he has stayed overnight with someone who has COVID-19, s/he will not attend class for 10 days from the day the symptoms of the person s/he lives with or stayed with started (or the day their test was taken if they did not have symptoms).
- If my child is in a high risk category for COVID-19 as defined by the UK government, I will obtain their doctor's approval before we attend class.

COVID-19 Practicalities:

- My child will clean their hands with soap and water or sanitiser on arrival at the class.
- My child will not touch anything not belonging to them in the hoop room other than the hoop and the crash mat that have been allocated to them (if participating).
- My child will use hand sanitiser or wash their hands after blowing their nose or coughing or sneezing into their hands.
- My child will place any belongings on the bench in the hoop room in a neat pile away from other people's belongings.
- I understand that my child may wear a face covering if they wish but that this is not required and others in the room may not be wearing a face covering.
- My child will bring everything they need for class (e.g., drinking water, sticky socks, hand chalk). If they need to borrow something from *Outoftheblue* I accept the COVID-19 risk that this sharing may incur.
- During periods when physical/social distancing is *not* legally required, I understand that the instructor and other classmates may approach aerialists at a close distance or touch them in order to keep them safe and I accept the COVID-19 risk that this may incur for my child.

Declaration
