

Terms and Conditions for the IdeaHQ Christmas Promotion

1. Introduction

These Terms and Conditions (the "Terms and Conditions") govern the IdeaHQ Christmas Promotion (the "Promotion") organized by IdeaHQ (the "Promoter").

2. Eligibility

To be eligible to participate in the Promotion, you must:

(a) Be an individual who is at least 18 years of age and residing in Australia; and (b) Submit an idea or innovation (the "Idea") that is original, creative, and innovative (c) Employees, contractors, and affiliates of IdeaHQ and their immediate family members are not eligible to participate.

3. Promotion Period

The Promotion will commence on 20/11/23 and close at 11:59 PM (AEST) on 22/12/23 (the "Promotion Period").

4. How to Enter

To enter the Promotion, you must:

5. Selection of Winner

The Promoter will select the two winners of the Promotion (the "Winner") from all valid entries received during the Promotion Period. The Promoter will consider the following criteria when selecting the Winners:

Prize one (a) Originality of the Idea; (b) Creativity of the Idea; (c) Innovativeness of the Idea; (d) Potential impact of the Idea; and (e) Feasibility of the Idea.

Prize two will be awarded to the participant with the highest number of valid submissions made by the one entity.

The Promoter's decision is final and no correspondence will be entered into.

6. Prize

The Winner will receive a prize of \$1,000 each (the "Prize"). The Prize will be paid direct into the winners account, upon announcement of the Winner & the Winner provides their bank details.

7. Intellectual Property Rights

By participating in the promotion, participants agree to grant the Promoter all intellectual property rights to all submissions, including but not limited to copyright, patent, and trademark rights. The Winner shall assign all intellectual property rights in the Idea to the Promoter by signing a Deed of Assignment or similar agreement. The Promoter reserves the right to use, modify, and distribute the ideas for any purpose without further compensation to participants.

The Winner warrants and represents that:

- (a) The Idea is original and creative; (b) The Idea is not the subject of any intellectual property dispute; and (c) The Winner has the right to assign all intellectual property rights in the Idea to the Promoter.

9. Privacy and Marketing

- (a) Participants agree to provide accurate information during registration. (b) The Promoter may use the provided details for marketing purposes and may share the information with third parties.

10. Disclaimer

The Promoter does not warrant or represent that the Idea will be successful or commercially viable. The Promoter shall not be liable for any losses or damages arising from the Idea.

11. Limitation of liability

The Promoter is not responsible for any lost, late or misdirected submissions. The Promoter is not liable for any damages or losses resulting from participation in the promotion.

12. Disqualification

The Promoter reserves the right to disqualify participants who violate these terms and conditions or engage in fraudulent activities.

13. General

- (a) The Promoter reserves the right to amend these Terms and Conditions at any time without notice. (b) The Promotion is governed by the laws of Australia. (c) Any disputes arising from the Promotion shall be resolved by the courts of Australia. (d) To the fullest extent permitted by law, the Promoter excludes all liability for any loss or damage (including indirect or consequential loss or damage) arising from or in connection with the Promotion.

These terms and conditions are governed by the laws of Competition and Consumer Act 2010 and participants agree to submit to the exclusive jurisdictions of the courts in Queensland.
