**Liability Waiver**

I have read this entire section, understood, and accept the disclaimer and liability waiver and sign it of my own free will. I recognize and understand that youth football is a physical contact activity and that my child's participation might result in serious injury, including permanent disability or death. I recognize and understand that such risk may be due to not only my own child's actions, but also the action, inaction or negligence of others. I recognize that there may be other risks that are not known to me or to others or not reasonably foreseeable at this time. I assume all of the foregoing risks and I accept personal responsibility for any damages that may result from injury, permanent disability or death. I enroll sign my child up for youth football entirely of my own free will and understand the importance of following the rules of training and competition. I certify that my child is in good physical condition, and has no disease, injury or other condition that would impair performance or physical and mental well-being during training, practice and/or competition. If my child has any injuries or illnesses that could affect ability to participate, I will notify the coaches and discuss the appropriateness of youth football with my or my child's doctor. I grant permission in case of injury to have a doctor, nurse, athletic training or other emergency medical personnel provide my child with medical assistance or treatment for such injury. The cost of any treatment or hospitalization arising from injury during training or play shall not under any circumstance be paid by Park Ridge Travel Falcons, its affiliated organizations and governing bodies, their officers, coaches or other members of the organizations, participants, supervisors, coaches, sponsoring organizations or their agents. I release, waive, discharge and covenant not to sue, Park Ridge Travel Falcons, its affiliated organizations and governing bodies, their officers, instructors and coaches, other members of the organizations, participants, supervisors, coaches, sponsoring organizations or their agents, and if applicable, owners and leasers of the premises from any and all liability to the undersigned, his or her heirs and next of kin for any and all claims, demands, losses and damages which may be sustained and suffered on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise.

In addition, I acknowledge the contagious nature of the Coronavirus/COVID-19, including the fact that the virus is easily spread, particularly in the sport of football, and is durable. I acknowledge that Park Ridge Travel Falcons cannot guarantee that my child will not become infected with the virus. I understand the risk of my child becoming exposed to and/or infected by the virus, and that it may result in sickness, serious injury and/or death. I hereby release and hold Park Ridge Travel Falcons harmless from, and waive on behalf of myself, my child, heirs and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself, my child, heirs and anyone else that may be caused by an act, or failure to act, by the Park Ridge Travel Falcons, or that may otherwise arise in any way in connection with travel football games, practices, or any other service or event received by you or your child from the Park

Ridge Travel Falcons. I fully understand that this release discharges Park Ridge Travel Falcons from any claim that I, my child, heirs or personal representatives may have with respect to any bodily injury, illness, death, medical treatment or property damage that may arise from, or in connection to, any service received from Park Ridge Travel Falcons. This liability waiver and release extends to the Park Ridge Travel Falcons together with its owners, partners, officers, directors, employees and board members.

**Media Release**

I understand that photos and videos from Park Ridge Travel Falcons games, practices and events may be used in promotional material for the team. I agree to allow my image or my child's image to be used for this purpose and that I will not be compensated. I also understand that once a promotional item has been produced, it is not possible to remove my image or my child's image from the production.
