



## Required Occupational Safety and Health Administration (OSHA) Training - General Industry

OSHA's mission is to protect workers across various industries and prevent work-related injuries, illnesses and deaths. To accomplish this, it sets and enforces specific safety standards—standards that businesses must comply with and train their employees on if they are to avoid significant fines. This resource provides an overview of common standards that general industry businesses must train on, highlighting which employees require the training and how often they need to be trained. Please note, these are just the minimum requirements. As a best practice to prevent workplace incidents, consider more frequent training. \*In addition to OSHA's required initial and periodic training, most OSHA standards require retraining when there are any changes to the workplace, equipment or job assignment—particularly if the changes could create a new hazard. Retraining is also required whenever an employee demonstrates a lack of understanding, knowledge or skill regarding training topics (e.g., an authorized employee isn't following a lockout procedure).

**OSHA 10 FOR  
CONSTRUCTION**

The Occupational Safety and Health Administration (OSHA) Outreach Training Program for Construction Industry provides training for workers and employers on the recognition, avoidance, abatement, and prevention of safety and health hazards in workplaces in the construction industry. The program also provides information regarding workers' rights, employer responsibilities, and how to file a complaint. This class is an orientation to occupational safety and health and is intended to provide workers with awareness of common job related safety and health hazards. Topics include safety data sheets, the OSHA Log of Work-Related Injuries and Illnesses, walking and working surfaces, exit routes, emergency action plans, fire prevention plans, electrical, personal protective equipment, and hazard communication. Topics may also include hazardous materials, material handling, machine guarding, basic industrial hygiene, blood-borne pathogens, ergonomics, safety and health programs, and fall protection. The course is taught by an OSHA-authorized instructor. Participants who successfully complete the course will receive an OSHA course completion card.

OSHA 30-hour Construction Industry Training course is a comprehensive safety training program designed for those working within the construction industry. The OSHA 30-hour courses provide essential information that helps safety committee members, forepersons, supervisors, superintendents, managers, competent persons, safety staff, safety managers, and others monitor workplace safety and implement OSHA health and safety regulations at their workplaces. Participants receive an OSHA 30-Hour General Industry course completion card in the mail after 1-2 weeks of completing the course.



## Wisconsin Builders Association Applauds Signing of Legislation

**March 21, 2024** – The Wisconsin Builders Association (WBA) applauded Governor Evers on signing three pieces of legislation that will directly benefit the home building industry and Wisconsin residents.

“It has been well documented and discussed that Wisconsin is facing a critical shortage of housing for the workforce across the state,” said WBA President Jim Doering. “The commitment shown by WBA, other statewide associations and legislators, and Governor Evers is imperative to helping solve this workforce housing crisis.”

- Senate Bill 413 establishes a clear framework for developers in facilitating placement of improvements in highway setback, and Wisconsin Department of Transportation’s (WI DOT) authority to approve subdivision plats, and has the potential to ease the burden to build more needed housing. Lead authors: Senator Cory Tomczk (R-Mosinee) and Representative Dave Murphy (R-Greenville)
- Senate Bill 580 adds construction to an existing program in which recipients will now have the ability to use funds for the enhancement or improvement of a technical education facility or equipment relating to construction; grant was previously solely for manufacturing. Lead authors: Senator Rob Stafsholt (R-New Richmond) and Representative Chanz Green (R-Grand View)
- Senate Bill 585 will create a small business tax credit for those who invest in workforce housing and/or invest in a childcare program for eligible employees. Lead authors: Senator Dan Feyen (R-Fond du Lac) and Representative Dave Armstrong (R-Rice Lake)

“While these pieces of legislation are vastly different from each other, easing development burdens, enhanced construction programs in schools, and housing investments for our workforce all have the ability to not only benefit the home building industry, but residents across Wisconsin,” said WBA Executive Director Brad Boycks.
