## **ABSOLUTELY NO PARKING IN THE FRONT LOTS.**

Size is approximately 10'x10' for a booth. Each booth will have backdrop and side curtains. (No signs can be hung directly on the backdrop curtain.) Full payment of booth rental due with Exhibitor's Contract. Exhibitor assumes all responsibility for damage caused by negligence, i.e. damage to overhead doors, etc. Exhibitors shall not injure or deface the walls or floors of the building, the booths or the equipment in booths. When such damage appears, the exhibitor is liable to the owner of the damaged property. The use of duct tape is prohibited. Tape will be provided by G.S.H.B.A. Removal of all tape is the responsibility of exhibitor.

Neither the HOME SHOW nor the service contractor nor the management of Sentry World nor any officers and/or staff members of the above will be responsible for the safety of the property of exhibitors from theft, strikes, damages by fire, water, storm, vandalism or other causes, unless caused by their or its negligence, but they will take reasonable precautions to protect the exhibitors from such loss. **EXHIBITORS ARE REQUIRED TO CARRY FLOATER INSURANCE TO COVER EXHIBIT MATERIAL AGAINST DAMAGE AND LOSS AND PUBLIC LIABILITY INSURANCE AGAINST INJURY TO THE PERSON AND PROPERTY OF OTHERS.** The exhibitor is charged with knowledge of all local laws, ordinances and regulations pertaining to health, fire prevention and public safety while participating in this showing. Compliance with such laws is mandatory for all exhibitors and the sole responsibility is that of the exhibitor.

ALL EXHIBITORS WILL BE REQUIRED TO FURNISH THE GOLDEN SANDS HOME BUILDERS ASSOCIATION A CERTIFICATE OF INSURANCE with limits of a minimum of \$500,000 per each occurrence/\$1,000,000 per aggregate.

The exhibitor is charged with the knowledge of national, state and local legal restrictions on any merchandising, advertising or promotional scheme which involves attracting visitors to an exhibitor's location by any inducement which might be construed as lottery. The HOME SHOW does not accept responsibility for any promotional schemes undertaken by the exhibitor

- NO ALCOHOLIC BEVERAGES are allowed to be served without prior GSHBA board approval.
- NO ANIMALS ALLOWED in exhibitors booth.
- **FACILITY DAMAGE PREVENTION: Tire booties and proper weight distribution will be required for all vendors/exhibitors bringing in wheeled carts, vehicles or machinery. Vendors will be responsible to provide booties for their equipment.**
- **NO FOOD OR DRINKS ALLOWED IN EXHIBITOR AREAS. All food must stay in vendor lounge.**

The Golden Sands Home Builders Association will be advertising through select medias.

By exhibitor, **no helium balloons.** Handouts from booths only. All handouts must pertain to your exhibit.

Use is permitted but they must not interfere with adjacent booths. **No booth can have a noise level that will interfere with other exhibitors.**

Security will be provided by the Golden Sands Home Builders Association, however the Golden Sands Home Builders Association accepts no liability for losses.

Exterior electrical, water hoses, and other special equipment not available from the Association.

The association reserves the right to limit cash sales.

Trailer or other large displays must be set up so as not to disturb other booths. (No exceptions.) Any outside displays must be okayed by the Chairman.

No person shall peddle, hawk, solicit or canvass or act as peddler, hawker, solicitor or canvasser within the convention area of the Golden Sands Home Builders Association, Home and Garden Show without first registering with and obtaining booth space from the Golden Sands Home Builders Association. If anyone approaches your booth soliciting please take their business card, flyer, information etc. and report the incident to the Home Show Chair, GSHBA President or any member of the Home Show Committee.

We agree with the rules for exhibiting set forth by the Golden Sands Home Builders Association. We understand that booths will be assigned on a first-come, first-served basis. We will try to honor all requests for booth locations, but final decision will be made by Home Show committee.
