Nominations (other than those made from the floor) must be received not later than March 6<sup>th</sup>, 2020.
- 3. To remain in accordance with the Navy League of Canada's National By-Law and proposed addendum para. 6.2(a), the number of Directors shall be fixed at (18) eighteen.
- 4. The ITE may make recommendations as to who it recommends for election to the Board, using the following criteria:
  - all current Directors-at-Large who have filed an acceptance form, remain eligible to serve and indicate a willingness to continue to serve will be recommended for election to the Board;
  - b. the recommendation of new nominees for election will be based upon an assessment by the ITE as to skillsets required on the Board.
