

# NAVY LEAGUE OF CANADA ONTARIO DIVISION

## OPERATIONAL DIRECTIVES AND INSTRUCTIONS FOR NAVY LEAGUE CADET CORPS

### 1. AUTHORITY

- 1.1 This order introduces and establishes a system for Divisional Standing Orders for Navy League Cadet Corps operating within Ontario Division. These Operational Directives and Instructions (hereafter referred to as ODI's) are promulgated by the Ontario Division Navy League Cadet Committee, and are authorized by the Ontario Division Vice-President, Navy League Cadets.

### 2. PURPOSE

- 2.1 These ODI's are intended to supplement the regulations governing Navy League Cadet Corps as authorized and issued by the National Council, and as such they will not set aside or overrule any National orders.
- 2.2 These ODI's will establish a better standardization of corps within the Ontario Division. Adherence to them will be mandatory and this adherence ascertained on all inspections.

### 3. ISSUING AND RETENTION

- 3.1 When these individual orders are promulgated and approved, they will be made available through e-mail, websites, etc. by the Ontario Division to all Navy League Cadet Corps, their Branches and all Area Staff of the Ontario Division. The same procedure will be followed in the issuing of amendments if and when they occur.
- 3.2 These ODI's, upon receipt, are to be inserted into the NL(8)E Regulations for Navy League Cadets as issued by the National Council or in a separate three ringed binder.
- 3.3 ODI's to be inserted in order of their identifying numbers.

### 4. NUMBERING

- 4.1 All ODI's will be categorized and numbered according to the following:

## 5. REVISIONS

- 5.1 Changes to any of these ODI's may be requested in any one of the following manners:
  - 5.1.1 Written submissions by Branches to the Ontario Division Vice-President, Navy League Cadets.
  - 5.1.2 Written submissions by Corps Commanding Officers to their respective Area Staff.
  - 5.1.3 Annual Commanding Officer's conference.
  - 5.1.4 By adoption as a regulation by National Council.
- 5.2 The final decision as to whether a revision will be instituted is that of the Vice-President Navy League Cadets and the Navy League Cadet Committee, in conjunction with the Commander, Ontario Division.
