Completed artworks must be brought to the Sackets Harbor Arts Center by 2:00PM, Saturday, July 20, 2024

Final judging will take place beginning at 2:15 PM, Sat. July 20, 2024

SILENT AUCTION

Anytime during the three-day event, bidders may enter a bid at the artists' workstation. All artworks submitted for judging must have a starting bid of at least \$50.00.

FINAL SILENT AUCTION

Final bidding auction will be on Saturday, July 20, from 2:00PM – 3:00PM, at the Sackets Harbor Arts Center outdoor tent. Bidding will close at 3:00PM Auction winners will then be announced. Any artworks with no bids will be available after 3PM, at any time during normal gallery hours, priced at the opening bid price, unless changed by the artist.

SALE OF ARTWORK

All artwork sold is subject to 8.00% Sales Tax. Artists will receive 70% of sale price, mailed to the artists' home address upon clearance of funds by AANNY. AANNY will retain 30% of sale price. Artwork sold during the auction becomes the property of the buyer who assumes responsibility to pay for and decide for its shipment if necessary.

## 2024 SACKETS HARBOR PLEIN AIR FESTIVAL RULES

It is our goal that the 2024 Sackets Harbor Plein Air competition will closely follow currently accepted Plein Air guidelines for national level Plein Air competitions. The following guidelines have been incorporated for this year's judged event, which should make your experience of Plein Air painting in Sackets Harbor both enjoyable and fair to all.

1. All artists must register (sign-in if preregistered) upon arrival at the Sackets Harbor Arts Center, 119 W. Main St. during the following hours:

Thursday July 18 – 8:00 am to 5:00 pm.

Friday July 19 – 8:00 am to 5:00 pm

No registration on Saturday July 20 (day of judging).

2. You do not need to sign in daily after initial registration.

3. Each blank canvas or painting surface intended to be entered by participants will be inspected for blankness and marked with an AANNY identification mark at the beginning of the competition. Each subsequent painting undertaken by the entrant also must be inspected and so marked. Any artworks entered for judging must bear the AANNY mark. There may be no pre-applied sketches of paint applications on works before AANNY inspection and marking for any artworks entered for judging.

4. Use of reference photos of the surrounding scene at workstations is not allowed. Artworks may not be completed from reference images of any kind and must be direct paintings of the scene surrounding the artist.

5. Artist may sign artwork. Artworks may be framed or framed and matted prior to judging. This is at the discretion of the artist.

6. It is the responsibility of the artist if he/she intends to sell their artworks, to provide suitable support mounting and/or framing devices that can be used to transport the artwork to the satisfaction of the buyer.

7. Artists may complete as many artworks as desired (see rule #3).

8. A limit of three (3) completed artworks per artist may be entered for final judging.

9. Only 2-dimensional artworks will be accepted. No photography or prints allowed.

10. All artworks must be completed in an outdoor setting within the village limits of Sackets Harbor, or within the Town of Hounsfield NY.

11. It is the responsibility of the artist to secure permission to paint on private properties within the village limits.

12. Artwork intended for judging must be brought to the Sackets Harbor Arts Center sign-in station at the Plein Air Tent, next to the Sackets Harbor Arts Center, by 2:00PM on Saturday, July 20.

13. All artwork entered in judging will be considered for sale, at listed opening bid price, or highest bid entered.

14: Artists will receive one (1) lunch ticket redeemable for one lunch consisting of hot dog, chips, soda at Statler's Ice Cream Stand at check in. Good any open hours during the 3-day plein air event through Saturday July 20.
