Update: Submission to City of London on Property Tax Deferral

Navigating Retirement believes that lower-income Londoners should receive relief from municipal property taxes. Don Pollock (our organization's President) made a submission as part of the London 2024 budgetary process. The recommendation is a deferral of property taxes until a residence is sold. There are similar programs in BC, Alberta, Saskatchewan, New Brunswick and PEI, plus most major cities in Ontario. The submission resulted in correspondence with Councillors Trosow and Franke, inperson meetings with Councillors Anna Hopkins and Corrine Rahman and Deputy Mayor Shawn Lewis. Don was impressed with the process as every politician embraced the issue and wanted to explore opportunities to help reduce poverty among seniors. Our team is optimistic that London will consider relief provisions. The province may also have a role to play so Don will be meeting next with Rob Flack MPP Elgin-Middlesex-London.
