# **Estate Planning Seminar Follow-up**

This question was raised after our October seminar on estate planning: "What if you are appointed estate trustee (executor) of a will, but you are not prepared to take on the responsibility?". Perhaps you were not advised of the initial appointment or circumstances have changed and you are no longer willing to perform the function. There are three potential scenarios:

- 1. If the individual has not yet died, the person selected as executor should advise that they are unable or unwilling to take on the role. It is best to communicate in writing.
- 2. If the individual has died and the individual selected as executor does not want the job and has not performed any activities on behalf of the estate, they can sign a form known as a renunciation.
- 3. The issue becomes more complex if the executor has commenced work on the estate, but no longer wants to be involved. The individual should seek legal advice as they may have to go to court in order for a replacement executor to be named.

#### **Error Rate by CRA**

The Auditor General released a report on the Canada Revenue Agency (CRA) and the findings included:

• The most significant finding was the low accuracy rate for individual tax advice, estimated at just 17%. However, if the question was business related the accuracy level improved to 54%

Answers to queries were often incomplete

CRA management has dropped the ball. They prioritized "soft objectives" rather than the technical competency of their employees. Despite this mismanagement, it is very important to understand that if you rely on **inaccurate information provided by CRA**, you are still subject to interest and penalties for any underpayment of taxes.
