### Tax Update

Q: I have a \$100,000 GIC earning 5%. I want to make it a jointly owned asset with my son. If I do, who pays the income tax on the interest earned?

**A:** Though the T5 will show both names, the interest is included as income of the person who contributed the money. Thus, the parent pays all of the income tax on the GIC.

# **Estate Planning Update**

# Q: What is an Estate Information Return and does every executor (estate trustee) have to file the return?

**A:** Beginning January 1, 2020, an estate representative must file an Estate Information Return with the Ministry of Finance within 180 calendar days after the estate certificate has been issued. The estate certificate is a probate document so estates that have not been probated normally do not have to file an Estate Information Return.
