Financial Planning Update: "Bitcoin 101" Article By Don Pollock

There are two parties involved in the Bitcoin market – miners and speculators:

- Miners Verify and record Bitcoin transactions. Miners are compensated by receiving fractions of a token they can sell. They use extensive amounts of computing power. For example, the electrical power used by miners exceeds the amount used by most countries. The total supply of bitcoins is restricted to 21 million and once they are all mined no future coins will be issued.
- **Speculators** Purchase coins on the belief that the value will increase. Losses can occur with a drop in value, or via corrupt players supposedly holding the coins, where they disappear through illegal activities. FTX would be a recent example.

Two theories are floating about Bitcoin's future value. Some believe it will increase rapidly in the immediate future as the SEC will allow Bitcoins to be included in ETFs. Blackrock and Fidelity are involved in this strategy. The negative view is significant Bitcoin amounts will be dumped on the market from bankruptcy liquidators which will depress the value in the near future. Who's right? It is beyond my skill set to answer!

Author's Note - I do not own cryptocurrencies, do not expect to purchase them in future, nor would I recommend anyone else invest in this product. While Bitcoin value increased by 70+% in 2023, and I know people who made significant amounts of money, that does not change my position. Bitcoin has proved to be an effective tool for money laundering, tax evasion and other criminal activities. While deep-pocketed investors with a taste for risk may want to consider Bitcoin, **seniors with limited savings are usually best to avoid high-risk investments of any type.**

Pandemic of Loneliness

Seniors for Social Action Ontario has released the following information concerning **loneliness and social isolation which are serious health risks**. The Centers for Disease Control and Prevention (2021) has documented serious health conditions caused by loneliness and social isolation which include:

- Premature death from all causes, "a risk that may rival those of smoking, obesity, and physical inactivity"
- About a 50% increased risk of dementia
- A 29% increased risk of heart disease and a 32% increased risk of stroke
- Higher rates of depression, anxiety, and suicide
- Among "heart failure patients loneliness was associated with a nearly 4 times increased risk of death,
 68% increased risk of hospitalization, and 57% increased risk of emergency department visits"
