### Consent, Release, Waiver, and Indemnification Agreement

#### 1. Parties

This Consent, Release, Waiver, and Indemnification Agreement (“Agreement”) is made this \_\_\_\_ day of \_\_\_\_\_, 2026, by and between Ante Hunt Club of Virginia, a Virginia nonstock corporation (“Club”), and \_\_\_\_\_, a member of the Club, (“Releasor”).

#### 2. Consideration

In consideration for participation in the activities of the Club as described in the Club’s Bylaws, Rules and Regulations, and Calendar, Releasor does hereby enter this Agreement.

#### 3. Consent

- A. Releasor consents to follow the Rules and Regulations and adhere to the Bylaws promulgated by the Club.
- B. Releasor certifies that he or she is physically and emotionally able to safely and legally engage in the activities of the Club.
- C. Releasor certifies that he or she executes consents to the Club’s Rules and Regulations and Bylaws freely, voluntarily, and after sufficient review.

#### 4. Release

- A. Releasor certifies and he or she has the authority to release the Club from any and all claims and has not transferred such authority to any other person.
- B. Releasor and Student acknowledge that there are inherent risks involved in the activities of the Club.
- C. Releasor agrees to release the Club, its directors, officers, employees, agents, and volunteers from any and all liability for injury, loss, or damage to person or

property that may occur during the course of Releasor's membership in the Club.

- D. Releasor agrees to attempt to settle any and all such claims through good faith negotiation with the Club. If good faith negotiation fails, Releasor agrees to attempt to settle all such claims through mediation with a professional mediator. If mediation fails, Releasor agrees that the laws of the Commonwealth of Virginia shall govern, and the jurisdictional forum shall be the courts of the Commonwealth of Virginia, City of Chesapeake. In any litigation, the prevailing party shall be awarded reasonable attorneys' costs and fees.

**5. Indemnification**

Releasor does hereby fully indemnify the Club to the extent permissible under laws of the Commonwealth of Virginia, as the same exists or may hereafter be amended, against all liability, loss, and costs (including, without limitation, attorneys' fees and costs) incurred or suffered by the Club by reason of or arising from Releasor's membership in the Club, participation in the Club events, or use of Club property.
