- **Regulatory or Legal Entities** when required by law or to protect the Museum's rights and property.

We do not share donor information publicly without consent, except as required by IRS regulations for nonprofit reporting.

4. Data Security

We use administrative, technical, and physical safeguards to protect your information. While no online system can guarantee absolute security, we consistently work to ensure reasonable protection against unauthorized access or misuse.

5. Cookies and Analytics

Our website may use cookies or analytics tools (such as Google Analytics) to understand visitor engagement and improve our site. You can adjust browser settings to refuse cookies if preferred.

6. Your Rights

You may request to:

- Review or correct your personal information.
- Opt out of marketing emails or newsletters.
- Request that we delete your information where legally permissible.
