

ORDER FOR INCORPORATING THE TOWN OF
DIETRICH AS A VILLAGE.

A petition having heretofore been filed with the Clerk of the Board of County Commissioners of Lincoln County, State of Idaho, signed by Edwin K. Gage and forty-nine other persons, praying that they may be incorporated as a village under the name of "Village of Dietrich", and showing the metes and bounds of said proposed village, which tract of land proposed to be incorporated as a village is situate in Sections 12 and 13, Township 6 South, Range 18 E.B.M., in Lincoln County, Idaho, and more particularly described by metes and bounds as follows:

Commencing at the point where the North and South half section line in said Sections 12 and 13 crosses the South boundary line of the right of way of the Union Pacific Railroad Company, which said point is the point of beginning; thence Westerly along the said South boundary line of said right of way for a distance of 872 feet; thence Northerly at right angles to said South boundary line of said right of way to the North Boundary line of said right of way; thence Easterly along said North boundary line of said right of way, 482 feet to the West boundary line of what is shown as Washington Street on a certain Plat of Dietrich filed in the office of the county recorder of Lincoln County, Idaho on or about April 11, 1924; thence due North along the West line of said Washington Street extended to the Northeast corner of Lot 7, Block 49 of said Plat, being on the South boundary line of Seventh Street as shown on said Plat; thence Westerly along the North boundary line of said lot seven, extended, a distance of 138 feet; thence due North to the South line of the right of way of the main Dietrich canal of the Big Wood Canal Company; thence in a general Easterly direction along the South line of said right of way of said canal to a point 1070 feet East of the North and South half section lines of said section 12; thence due South to the South boundary line of the right of way of the Union Pacific Railroad Company; thence West 1070 feet to the point of beginning.

and it appearing to the Board and the Board finding that more than a majority of the taxable inhabitants of said proposed village have signed said petition, that said petition is in due and legal form and order, and that inhabitants of said tract of land to the number of more than 125 ~~are~~ actual residents of the above described tract, and that said petition should be granted for said Town of Dietrich's incorporation:

NOW THEREFORE, it is hereby ordered that said proposed village having the metes and bounds shown above, be and is hereby incorporated as a village under the laws of the State of Idaho.

It is further ordered that Ned Bolton,
Walter Fechner, C. H. Frees, Jerry Church,
Kent Gage, be and they are hereby appointed as
trustees of said village, who shall hold their office and perform
all the duties required of them by law until the election and
qualification of their successors at the time and in the manner pro-
vided by law.
