## The Second Sunday of Advent ♦ December 7 ♦ 10:00 AM the Rev. Katie Lyon

At the heart of our Advent preparation stands John the Baptist, who calls us to repent and make a new beginning. As the darkness increases we turn toward the approaching light of Christ. For Christians he is the root of Jesse, the righteous judge who welcomes all, especially the poor and meek of the earth. We wait with hope for that day when the wolf will dwell with the lamb, and there will be no more hurt or destruction.

From the Lord's table we are sent in the spirit of John the Baptist to proclaim that in Christ the kingdom of God has come near.

## The Third Sunday of Advent ♦ December 14 ♦ 10:00 AM the Rev. Katie Lyon

A note of joyful expectation marks today's worship. Isaiah announces that the desert shall rejoice and blossom, and Jesus points to the unexpected and transforming signs of God's reign. We wait with patience for the coming of the Lord, even as we rejoice at his presence among us this day: in word and holy supper, in church and in our homes, in silent reflection and in works of justice and love. We pray that God would open our eyes and ears to the wonders of Christ's advent among us.

## The Fouth Sunday of Advent ♦ December 21 ♦ 10:00 AM the Rev. Katie Lyon

Children and youth lead us into the story of the first Christmas with the stable animals, the angels, the shepherds, and the Holy Family—Mary, Joseph, and the infant, Jesus.

We sing the familiar carols of the season and gather around the altar to taste and see the Incarnate Christ.

Jesus begins his public ministry by calling fishers to leave their nets and follow him. In Jesus the kingdom of God has come near. We who have walked in darkness have seen a great light. Light dawns for us as we gather around the word, the font, and the holy table. We are then sent to share the good news that others may be "caught" in the net of God's grace and mercy.







The Mission Endowment Fund provides funding to support mission outreach to the congregation and the broader community.



## **Community Center Update**

Last year, the Congregation Council made the difficult decision to close the Community Center adjacent to the main church because the building is in need of extensive repairs and Council does not believe that it would be good stewardship for us to invest in the building. Over the last year, we have been considering our options for the property. Demolishing the building and developing the site as open space would likely cost more than \$150,000.

The property is currently zoned for a residence, church, or municipal building. The land on which it sits is a part of one large parcel that includes the main church buildings and both parking lots. In order to ascertain (a) whether we could sell the property and (b) what type of proceeds a sale might render, we must determine if the borough would allow us to (a) re-zone the property as commercial and (b) subdivide the Community Center as a separate lot from the remainder of the church property.

So far, we have received preliminary approval for the property to be re-zoned as commercial. That final decision will come before the borough Council in early December. If that is approved, the next step would be to ask the borough for permission to subdivide our one big parcel into two separate parcels. That approval process could take several months. If we receive approval to re-zone and subdivide, then we will be in a better position to quantify proceeds that could be realized from a sale. At that point, Council will need to decide whether to offer the property for sale. Proceeds from a sale of the property could be used for other ministry work or the preservation and maintenance of our other property.

If you have any questions or concerns about this process, please do not hesitate to talk to Kate Harenza or any member of the Congregation Council as we welcome all thoughts and want to be as transparent as possible.
