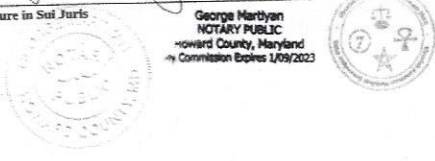

I am a natural born indigenous Moor of the Moorish Universal Society of Tribes, in Propia Persona (pro per/pro se) and domiciled in New Kemit, Miami Valley Region, Montgomery, Butler, Warren and Hamilton Counties, Ohio, America(s) Republic. I am a member of the Moorish Temple of New Kemit. I am a Non Resident in The Republic of Maryland, Montgomery County.
2. I have no disabilities, which would prevent me from making this affidavit.
3. I am a manifestation from the Creator Most High. I am a Moorish National. I am the descendant of Africans from the Moorish Empire (Spain, Morocco, Tunis, Egypt, Palestine/Israel, Saudi Arabia, Abyssinia/Ethiopia, Nigeria, Ghana etc.) Asiatic, Tribe of Shabazz, Marrano, Fellaheen, Ovambo, Bantu, Bamileke, Tswana, Maputo, Cabinda, Soho, Sephardic, Israel, Tribe of Dan and the dark indigenous people of North America (Olmecs/Washtaw/ Jamasee Tribes/Müür/Muracanos etc.). I'm foreign to Federal U.S. See: 8 USC 1101 (A)(2)(B), 1401 and USC 349.
4. I am NOT black, Negro, colored, African American, Afro American or any colorable name given to people of African descent before and after slavery (involuntary servitude).
5. I will conduct my personal /religious affairs under 1st Amendment in the Republic of New Kemit, MUST, Ohio State Republic and Maryland State Republic. This is done in pursuant to: Universal Declaration of Human Rights, 1948, (Article 15 section 1 and 2), Treaty of Peace and Friendship of 1787 with Murakush, Ohio Constitution, 1802, Maryland Constitution (1867), Declaration on the Rights of Indigenous peoples, The United States Constitution, 1791, (Article VI section 2 and 7th Amendment) Treaty of Camp Holmes (1835), HJR 75 1933 Philadelphia Moor American Society and Moorish Temple of New Kemit's Constitution Bylaws (2006), MUST Constitution and Bylaws.
6. I, being of full age of Majority, affirm my ability to operate an automobile, and not a motor vehicle, but for religious reasons upon the public roadways to all Temples, Churches and cultural institutions. I RESERVE MY RIGHTS to unlimited religious travel. The Right to Travel; The Right to Mode of Conveyance; The Right to Locomotion are all absolute rights, and the Police can not make void the exercise of rights. State v. Armstead, 60 s. 778, 779, and 781: Title 18 USC 31.
7. I am not a legal person, or a legal fiction. I am not a citizen governed under naturalization or immigrations, NOT a 14th Amendment "person" or a Federal U.S. citizen. I am not a citizen of the District of Columbia or any federal jurisdiction or a corporate entity. I cancel all past signatures, authorizations, citizenships or franchises with any agency. All previous signatures are colorable and made under threat, duress and coercion. I am NON TAX OBLIGATED to the Federal U.S. and States due to my Moorish religious faith. My Non Tax Obligated Indigenous Band Number is AA 222141. My Temple Non Tax Obligation number is 47-4662554. I reserve the right to contract.
8. I am not wanted, or under indictment for any crime in Ohio, Maryland or abroad, under Common law.
9. This affidavit was not made under threat, duress and coercion and without deception for purposes of evasion. THIS IS A TRUE AND ACCURATE RECORD OF MY INFORMATION.
10. If any part of this affidavit is found fraudulent, it will be null and void and will be subject to prosecution under applicable law.
11. I hereby attest that I will protect and defend the U.S. Constitution (Art. 6 Sec. 2 and First Amendment) Art. 1 Sec 3 of Maryland Constitution, Ancestral Rites of Passage, MUST and Moorish Temple of New Kemit's Constitution/by laws.

I EXPLICITLY RESERVE ALL UNALIENABLE RIGHTS WITHOUT PREJUDICE pursuant to UCC 1-308, and (OHIO REVISED CODES 1301.13) UCC 1-103.6, and MD Comm L Codes 1-308.
